ABOUT: A juried exhibition open to artists working in all mediums. The theme for this exhibit is ANIMALS.

DESCRIPTION: For this show make your love for animals the focus of your piece. Please include an artist's statement about your piece.

We will be donating 50% off the entry fees to the Humane Society of the United States; specifically, their animal rescue efforts associated with natural disasters such as hurricanes, tornados, and wildfires. Artists can also *choose* to donate a percentage of their art sales to the HSUS.

Opening Reception: Thursday, February 13, 2020 from 6-8:00 pm.

Awards Ceremony: Thursday, February 13, 2020 at 7 pm.

Exhibition Dates: The exhibition and sale will be open and free to the public from Thursday, February 13, 2020 through Saturday, March 14, 2020.

Gallery Hours: Monday through Friday, 10-6, Saturday, 10-4.

Eligibility: The exhibition is open to artists 18 years or older. All work must be original work. Students must not present work for consideration if assisted in any way in arrangement or execution. Artists accepted for the exhibition will be asked for an artist bio for display purposes.

AWARDS: Best of Show: 50/50 split from entries, Juror's Award: \$25

JURORS: Priya Rama and Peggy Steinberg

PREPARATION OF ARTWORK: Size and weight of work is limited to that which can be moved by one person. Two-dimensional work is limited to 30" x 30" including artwork and framing. Work should be finished for display; meaning framed or museum wrapped canvas (please, no staples or nails showing on the edges). Any work that is to be hung, including three-dimensional works, must be appropriately wired, and strong enough to support the piece. The label provided in the entry form must be filled out and affixed to the back of the hanging piece or the bottom of a standing piece.

ENTRIES: An entry fee of \$20 for the first entry, \$10 for each additional entry. Up to 4 pieces can be entered into the show. Payment can be made by check or through PayPal (available at www.poprevolutiongallery.com). Digital files submitted by email will be reviewed when payment is received.

SCHEDULE:

- Deadline for delivery of artwork for judging: Thursday, January 30, 2020.
- Notice of Acceptance: by Wednesday, February 5, 2020.
- Drop off of Accepted Artwork: by Tuesday, February 11, 2020.
- Pick up of Artwork not accepted: by Saturday, February 8, 2020.
- Pick up of Accepted Artwork after the show: Should be picked up by Tuesday, March 17, 2020. Work shipped in will be shipped out starting March 20.

SUBMISSION OF ARTWORK:

- 1) Images of artwork can be sent via email to poprevolutiongallery@gmail.com, jpeg format, 180dpi, longest dimension sized at 10". Entry fees should be mailed to address below. Images should be titled as such: 'artist-lastname.title-of-work.jpg'.
- 2) Images of artwork can be burned onto CD and mailed along with entry fees to address below, jpeg format, 180dpi, longest dimension sized at 10". CD should be labeled with artist name, images should be titled as such: 'artistlast-name.title-of-work.jpg'. All digital files will be destroyed after opening reception.
- 3) Artwork can be delivered in person to Pop Revolution Gallery along with entry fee.
- 4) Artwork can be shipped. **NO PACKING PEANUTS PLEASE**. All shipping, insurance and transit costs are the responsibility of the artist. Work may be sent by the artist's desired carrier. A carrier of the gallery's choice will return shipped artwork to the artist, C.O.D. Artists with shipping accounts (i.e. UPS, FedEx) may send us a return slip. If your shipping address is different from your mailing address, please include alternate street address on the form. We do not ship to P.O. Boxes.

ENTRY PROCEDURE REGISTRATION AND FEES: The non-refundable entry fee is required. Fill out completely and mail to be received by January 30, 2020 the Registration Form below with payment for each entry. Entries submitted without payment or received after January 30 will not be eligible. Deliver your work, with labels attached, to Pop Revolution Gallery, 105 E. Main Street, Mason, OH 45040 according to the schedule above.
