SIGNIFICANT IMPACTS Working collaboratively with a diverse team of non-profits, municipalities, and community leaders



Our LNRP Team restores rivers, streams, wetlands, and forests within the Lake Michigan Basin.

The Little Manitowoc River and Coastal Wetland complex was a rapidly-deteriorating waterway after the flood of 2008. The 2.5-mile long river, draining into Lake Michigan and its associated wetlands, had been neglected for years. The primary river channel was full of sludge and the coastal wetland was full of invasive species. The poor water quality and wetland function was not supporting fish or migratory birds. So, our LNRP Team responded, and in partnership with the Fund for Lake Michigan, the City of Manitowoc, the Friends of the Manitowoc River Watershed, and other environmental and community stakeholder groups, we came together to act.

Today, the Little Manitowoc River supports fish, birds, and other wildlife – and the quality of the water flowing into Lake Michigan is vastly improved. Community residents can access it for kayaking, fishing, and bird-watching. And, economic activity nearby has increased.

Along Waldo Boulevard my eye caught a bird soaring above the Little Manitowoc River, an eagle. On the water to my right were a pair of Sandhill Crane along the shore, with ducks floating midstream and pelicans nearby. In one swift movement, the eagle dropped to the river's surface, snatched a fish in its talons and flew off with its dinner! I took a deep breath and just paused for a moment ... filled with gratitude for the work LNRP has done in restoring that very special habitat."

We believe the most complex and seemingly insurmountable challenges can be solved when people come together and get to work.

Today's climate crisis threatens our Wisconsin coastal communities, and to respond effectively and prepare for future impacts, trust-based relationships and collaborative actions are vital.

In 2020, our Lakeshore Natural Resource Partnership (LNRP) team embraced the leadership mantle. Together with Water365, we launched our "Coastal Resiliency Community Impact Project" (CRCIP), with a focus upon providing vital capacity-building support to our resource-limited municipal and county partners.
