Anyone can be a philanthropist (really!). London Community Foundation is **your** Foundation — created by people like you, for the community, forever.

We realize the power of our donors' collective impact through the Foundation's endowment, year after year. The endowment, built by donor support for more than 60 years, now stands at \$75 million and enables \$3–\$4 million in granting annually. This is all thanks to you – individuals, families and organizations in our community who believe in making London and Middlesex a more vibrant and caring community.

One of our past board chairs, Bob Siskind, said it best: "It's like contributing to a savings account for our community— one that keeps giving back." Through the power of endowment, we're able to maintain a long-term vision while making an impact, now and forever.

We're proud and honoured to be part of this incredible movement. In 2016, we were able to do more than ever before. Reaching new heights, the Foundation granted \$3.4 million to 179 charities and was the catalyst of several game-changing initiatives.

Our Vital Signs report was a bold call to action highlighting the need for mental health and addictions agencies to streamline the delivery of care. Since the release of this report, the Foundation has been advocating for collaboration and enhanced communication between organizations in this sector. Additionally, we made our largest grant yet, an amount of \$378,000, to Family Service Thames Valley. In partnership with Anova, Craigwood Youth Services, Women's Rural Resource Centre, Vanier Children's Services, and WAYS Mental Health Support, their resources and experience will combine to deliver a walk-in/talk-in clinic providing seamless service for people of all ages- now, that's game-changing!

Another important project we supported was the Welcome Fund for Syrian Refugees. The Foundation partnered with Community Foundations of Canada,

Manulife, CN, and GM to contribute \$250,000 locally to the London United for Refugees Initiative, a collaboration between the London Cross Cultural learner Centre, United Way London and Middlesex, and the City of London. The Welcome Fund for Syrian Refugees provided an important investment in the successful resettlement of hundreds of refugees in our community with a particular focus on supporting accessible and affordable housing.

In addition to our granting, The Foundation also made inroads into the world of impact investing. Launching the social impact fund, to replace the loan fund, this has expanded our social finance mandate to offer more funding options to non-profits and social entrepreneurs, as well as opportunities for donors who are looking to make social investments that have local, national and global impact.

As for Back to the River, the environmental assessment is well underway and promises to be complete by 2018. We are excited to announce that several donors have come forward to fund both the inaugural project at the Forks as well as the second project in the SoHo neighbourhood. This support validates the vision of this initiative as well as the Foundation's role as a leader and mobilizer of change.

These are just a few examples of how the Foundation is making an impact in the community through your generosity. This is your community and your Foundation. It's thanks to you that we're able to create community change now and for years to come.

We hope you will feel inspired by the stories in this report and join us in celebrating *you*.





Community Vitality: *Quine-Qhangers*

FUNDED BY THE SMART & CARING COMMUNITY FUND, the Community Vitality grant program strives to build a strong and vital community by investing in initiatives that will move the needle on our community's most pressing issues identified in the Foundation's Vital Signs report. The Community Vitality grant program supports high-impact, innovative, and collaborative initiatives that will create systemic change in the London and Middlesex Region. Thanks to your commitment and dedication to the community, we were able to grant \$1 million to four game-changing initiatives.

Transforming the System Response to Mental Health Through Cross Sector Collaboration

Family Service Thames Valley • \$378,000 over 2 years

This project will transform the system response to mental health in London and Middlesex by working collaboratively across organizations and sectors with mental health community partners to leverage resources and expertise. Through the creation of a whole life, mobile, walk-in/talk-in clinic, this project will break down silos that shift the way we support and respond to children and adults with mental health issues.



The London Community Workshop

Pathways Skill Development & Placement Centre • \$190,000 over 2 years

The London Community Woodshop will break down social barriers that lead to isolation through an inclusive and accessible community woodshop. With affordable memberships the London Community Woodshop will offer seniors, adults, and retirees skill development, mentoring, social supports, therapeutic programming, and shared learning opportunities.



London/Middlesex County Hoarding Support Services Network

VHA Home HealthCare • \$186,000 over 2 years

The Hoarding Support Service Network will focus on building the capacity of community agencies in London/Middlesex to respond to low-income individuals who are struggling with serious hoarding issues, which are jeopardizing their own safety (and possibly the safety of others), and their housing. Nothing like this currently exists to address this challenging issue. A service network will enable a customized service solution for our community.



Youth City

Boys and Girls Club of London • \$85,200 over 1 year

Youth City is an initiative by youth, for youth. A revamp to the Boys and Girls Club's regular programming, Youth City will allow youth to build skills, and explore career opportunities by expositing them to digital creative activities. In collaboration with local organizations, the programming will focus on areas of science, technology, art, design and math. Youth City will ensure that youth have access to all opportunities to learn, grow and become prepared for life as independent adults and future leaders within our community.

Community Fund for *Quanda's 150th*

AS WE CELEBRATE CANADA'S 150TH ANNIVERSARY, we reflect on not only 150 years but 150+. That is, we honour not only the 150th anniversary of Confederation, but the Indigenous Peoples who came before us, their history and their heritage. Canada's 150th anniversary of Confederation is a historic moment with the power to bring people and places together as we dream big about our communities and country. It's a chance to encourage all Canadians to contribute to their communities in a way that will foster a greater sense of belonging, support meaningful reconciliation and leave a lasting legacy now and for future generations.



Andrew Young is making money have meaning through the Community Mortgage Movement; an initiative that allows his clients to give back by donating percentage of his commissions to his fund, the AY Foundation.

Growing up, Andrew never dreamed he'd be able to start his own foundation.

"Raised in a modest household, I just didn't realize what was possible," he said.

After his father's passing in 2011, Andrew felt inspired to give back to the community but didn't know where to start. A quick Google search led him to London Community Foundation. Before he knew it, Andrew found himself a participant in the 2011/2012 Engage! London class. Surrounded by like-minded young professionals who were passionate about making a difference, this experience was a turning point in Andrew's life.

Fast forward to 2015, Andrew was thriving professionally as a local mortgage broker and had received personal gratification through his volunteer experiences working with various boards and committees in the city. Now, Andrew was ready to share the gift of giving with others in the community.

Andrew saw a need for smaller organizations and individuals to not only start giving, but to think bigger when giving back. He believes giving back should be a community approach; that was the inspiration for the AY Foundation.

"With London Community Foundation you're making an impact now AND later. I can have a living legacy. I feel an immense sense of pride knowing that I'm creating real community change."

Through the Community Mortgage Movement, Andrew is helping others support the community through collective impact. With a percentage of his commission going back to the AY Foundation, Andrew uses London Community Foundation's Vital Signs report to guide his granting decisions each year.

"The Community has given so much to me and I want to make it stronger," says Andrew. I am very fortunate to be in the position that I am, so I believe it's important to help those in need."

At 38 years-old, Andrew breaks down stereotypes that you need to wait until you're older and wealthy to be a philanthropist.

"Why wait to give? Anyone can be a philanthropist. The earlier you start, the more people you can influence. If you give back over a longer period of time, you're able to have an even greater impact on the community."

Fostering Positive Health through Preventative Care

For some individuals in our community, certain aspects of health care remain out of reach. Though our health care system is inclusive for the most part, many individuals find themselves unable to afford the care they need when OHIP coverage falls short.

Dr. Larry Patrick, Medical Director, Cardiac Fitness Institute (CFI), London Health Sciences Centre (LHSC), has dedicated the last 36 years of his life to bridging that gap so patients can receive the care they need, when they need it most.

Cam Willis, Donor-Advised Fundholder, has been one of Dr. Patrick's strongest supporters over the years.

A true unsung hero, Dr. Patrick runs the CFI at LHSC, a program that relies completely on the support of local donors. Providing integral, preventative care to those who are at risk or have suffered from heart disease or cardiac arrest, Dr. Patrick has the privilege of impacting the lives of his patients every day.

"Dr. Patrick's efforts to create and grow the CFI at LHSC –Victoria Campus helps scores of cardiac patients pursue exercise, nutrition and general well-being in a facility that does not require the patient to pay significant sums in order to get better, or to become stable and enjoy life to the fullest," says Cam. "Many of the patients would not be able to afford this type of care or facility because of the expense they would incur. Moreover, they are in a managed and supervised program that is second to none."

Understanding the importance of prevention in cardiac health, Dr. Patrick founded the CFI at LHSC 36 years ago. The centre focuses on cardiovascular risk management. Since some of the most common adjustable risk factors for cardiac problems include smoking, high blood pressure, diabetes and elevated cholesterol, Dr. Patrick's programs are aimed at providing patients with the tools to improve these areas such as exercise and nutrition advice.

"Cam is one of our biggest fundraisers," says Dr. Patrick. "His regular generosity is really appreciated. He goes above and beyond the call of duty."

It is donors like Cam who make this program a reality. Dr. Patrick sees 1000-1800 patients of all ages come through his door at the CFI each year. It's thanks to his generous supporters that he is able to bridge the gaps for those individuals who otherwise would never be able to afford these services.

"I am pleased to be able to support this program through London Community Foundation because I know first-hand of its success and what this program is able to do for anyone who wishes to use its services," says, Cam. "Dr. Patrick works tirelessly to make it happen and is to be commended for his efforts. There is not a lot of glory to be gained publically in his efforts, but I for one am most grateful for all his support and services that the Institute provides. I am glad that our Family Fund supports it and hope that others will help it grow and flourish."

Foundation Launches Social Impact Fund

The Social Loan Fund is a social investment program that turns donations into capital loans for community and non-profit groups. With access to funding that they typically couldn't get from a bank, groups can further their mission more efficiently and effectively.

In 2016 the Loan Fund's main priority was the development of safe and affordable housing in the London Community. Offering builders of affordable housing up to \$500,000, the loan fund is a social investment that contributes to building a resilient community.

In last year's annual report we shared the first success of our Social Loan Fund, providing a \$500,000 loan to support a local entrepreneur who was building an affordable housing project in the downtown core.

In 2016 we issued our second loan in the amount of \$500,000 in support of the Italian Seniors Project (ISP). Building off the success of their inaugural "Residenza Italia", an affordable housing project built in 2011 and winner of numerous awards for both its architecture and social impact, this second loan will support a new affordable housing project for individuals of all ages.

The Social Loan Fund held outside of the Foundation endowment gives donors who have contributed to this fund the ability to directly support affordable housing projects. In 2016, the Foundation set aside \$1,000,000 for the purpose of providing the loans that will support this program and entered into an agreement with the Libro Credit Union for the purpose of supporting and administrating access to the loans.

Like many Foundations across Canada and around the world, our board challenged LCF to come up with a long-term social finance strategy that was sustainable and could align more of our investments with our mission.

A special task force was created consisting of volunteers from each of the Foundation's committees, ensuring that the recommendation to the Board had an integrated and cohesive strategy aligned with the Foundation's mission statement and values.

As a result in 2017, the Foundation will be launching the "Social Impact Fund", which will replace the Social Loan fund. This fund will continue to be held outside of the Foundation's endowment and will expand the mandate to include increased funding and financing options for not-for-profits and social entrepreneurs looking to unlock capital in order to achieve their desired social enterprise outcomes. We will continue to prioritize local and direct opportunities, however we will work with partners both on a regional and national level if investments exist that align with the Foundation's values and target priorities.

An increased allocation of up to 5% of assets, will give the Foundation an opportunity to participate in additional projects and increase our "impact" in the community and beyond. Helping us continue to align more of our investments with our mission.

I've been aware for some time that London lacks affordable housing, and that getting vulnerable people housed really helps stabilize their lives and benefits their well-being in so many ways. As a donor, I was only too happy to contribute to a fund that would directly address this issue. I'm excited to see the progress it's already made and I look forward to seeing what else this fund can accomplish in the future.

Italian Senior's Phyject

Thanks to a loan from London Community Foundation's Loan Fund, the Italian Senior's Project will embark on its second affordable housing project that aims to provide a sense of belonging to all residents.

There was something about the 1109 Hamilton road apartment building that captured Mary Manning's attention the first time she drove by.

"I had a feeling that this was the one, this was my new home," she exclaims. "It had a unique look to it." It was then and there that she decided to take a leap of faith and add her name to the waiting list for a unit. This turned out to be one of the best decisions Mary has made.

In addition to the striking architecture, beautiful walking paths, gardens, and indoor amenities, there's something special about Residenza Italia that sets it apart from other affordable housing units - a sense of community.

Residenza Italia is an affordable housing unit that was conceived by the Italian Senior's Project, a registered charity created in response to the need for affordable housing for seniors in a culturally sensitive environment.

The 52 unit Residenza Italia has been fully occupied since it opened its doors in 2011. The building which became an award winning design by Nicholson Sheffield Architects has had a significant positive impact on the lives of seniors in the London area. That's because Residenza Italia is more than just affordable housing, it's about building community and a sense of belonging.

"It gives me piece of mind knowing that people look out for you here," says Mary. "You don't get that in other places. You never feel alone. There's a real sense of community."

Without places like Residenza Italia, seniors may find themselves isolated, living alone or in long-term care facilities. This affordable housing unit provides seniors with limited income another option that allows them to thrive in a supportive, community environment.

"We believe in affordable housing; we saw a need for affordable housing, and the need can be seen through the ageing demographics and number of seniors waiting for quality affordable housing," says Carla Garagozzo, Board Chair, Italian Senior's Project.

Thanks to a loan from London Community Foundation, a second unit across the street will be built. However, this time the new 62 unit building will welcome individuals and families of all ages. Additionally, the board hopes to set aside a number of units to support local veterans in need of housing.

Due to the success of the first project and the identified need for affordable housing, this new Hamilton Road unit will bring the benefits of Residenza Italia to the general population.

Carla believes the impact Residenza Italia has on people's lives is a reward you cannot buy.

"Knowing that you're improving people's lives is an incredible feeling. To know these people are in a place where they are happy and have a community of people who care about them makes all the hard work worth it."



The Time is Now

London Community Foundation's 2016 Vital Signs report brings awareness to gaps in mental health and addictions care.

Repeated visits to the emergency room, endless waitlists, incorrect diagnoses, lack of post care support, bouncing from one service provider to the next: this is the state of the mental health care system, and a reality that many individuals face every day.

On October 4th 2016, London Community Foundation launched its biennial Vital Signs report - a community 'check-up' that examines issues that are key to quality of life and well-being. Focused on the issue of mental health, the event brought together local mental health and addictions leaders, individuals of lived experience, mental health advocates, donors and community influencers. The message that morning was loud and clear: mental health is the single greatest issue facing our community. The community needs a transformative change in the way mental health services are delivered for efficiency, service capacity and sustainability.

For the past several years, the Foundation has observed an influx of grant requests targeted at tackling the issue of mental health, specifically regarding systems coordination in our local community. Crisis response, wait times, and coordination between service providers to address the gaps for individuals who are at-risk or in transition, are just a few of the most critical needs.

These challenges are all too familiar for David and Lee Ann Berlet who shared the story of their late son, Austen Berlet, who battled with mental health. "In hindsight, what would we have liked the system to offer us? The answer is simple: we would have liked to be a part of the solution. No parent should ever have to feel the immense pain and loss that we have," exclaims David.

As leaders and mobilizers of social change, London Community Foundation is taking a stand to address this pressing need. In response to the findings in our 2016 Vital Signs report, the Foundation believes there is a need to convene mental health stakeholders to catalyze change in our mental health system.

Vital Signs 2016 is not only challenging stigma that exists in our local community but is addressing systems gaps, calling for a more inclusive network of mental health organizations. It identifies a need to unify resources and organizations to provide help to individuals who need it, in a comprehensive, all-encompassing, and unified system.



London receives \$250,000 from Welcome Fund for Syrian Refugees

For newcomer Syrian refugee families who have experienced conflict, political unrest and displacement, settling into their first home in Canada is the first step to feeling a sense of belonging as new Canadians.

Housing instability can compromise successful settlement and integration, negatively impacting quality of life. This is why offering Syrian refugee families support with affordable housing has been the primary focus of Community Foundations of Canada's Welcome Fund for Syrian Refugees.

Offering support with housing, job training and skills development, the Welcome Fund has been our movement's collective response in welcoming refugees from Syria to Canada. The Welcome Fund was seeded by Manulife, and quickly augmented by CN's historic \$5 million donation, as well as by generous support from GM and community organizations.

As Canadians welcomed refugees from Syria, the Welcome Fund provided an important investment in their successful settlement in cities across Canada. Established to respond to an urgent gap in accessible and affordable housing, the Welcome Fund invested in community-driven solutions that enabled newcomer families to transition into suitable permanent housing.

In Partnership with the Welcome Fund, London Community Foundation announced a \$250,000 contribution to London United for Refugees, a collaborative initiative between United Way, Cross Cultural Learner Centre, and the City of London. This funding has provided support to three housing stability programs that supported the transition of these new Canadians in their new homes.

- 1. Cross Cultural Learner Centre, Housing Assistance Fund
 - Provided an additional source of funding for Syrian refugee families who are experiencing difficulties in finding and securing adequate housing and require immediate, short-term assistance to pay for the cost of housing.
- 2. LUSO Community Services, Cultural Awareness & Sensitivity Training for Landlord & Building Managers Provided customized training to landlords and building managers about cultural differences and how to best support newcomers residing in their buildings.
- 3. South London Neighbourhood Resource Centre (SLNRC), Good Neighbour, Safe Home *Introduced new Syrian families to local support services by hosting interactive community events.*

As of March 10th, 2016, more than 880 Government-Assisted Refugees from Syria arrived in London, Ontario. Efforts like the London United for Refugees initiative are key in supporting the successful settlement and integration of Syrian refugee families.



2016 Financial, Investment, and Operational Highlights

London Community Foundation ("LCF"), through its Finance & Investment Committees, has been diligently managing over \$70 million of assets during 2016 to ensure stable and consistent community impact in 2016 and beyond.

LCF is once again pleased to report strong financial results for the year ended December 31, 2016. The generosity of our donors past and present has resulted in donations of \$2.3M (2015: \$4.4 million) for the year. Our donors commitment to their funds, as well as support for our community leadership projects allowed us to grant \$3.4 million in 2016 (2015: \$3.6 million), making both our 2016 and 2015 our two biggest years of granting in the 62 year history of the Foundation. Our Investment Committee through their continued role in monitoring and oversight of our endowed assets saw continued growth in our overall invested assets. 2016 investment returns generated a return of 7.9% (2015: 4.9%) adding an additional \$4.8 million investment income (2015: \$2.5 million).


2016 Year in Review

2016 was another good year for our Endowment fund. LCF's focus on balancing between our capital preservation mandate and investment growth in our portfolio saw continued success in managing our invested assets, volatility and risk during the year.

Asset Allocation of the Investment Fund

The Investment Committee continued commitment to the strategic asset allocation in 2016 (same in 2015), and rebalancing with the following target asset mix.

London Community Foundation is a long-term investor and believes the asset mix, combined with value added



performance from our investment managers, ensures we can continue to impact our community in a positive and meaningful way.

Investments

The total assets of the Foundation's primary endowment portfolio ("Endowment") at December 31, 2016 were \$66.9 million, representing 93 percent of the total assets (2015 - \$64.2M and 93 percent of total assets).

The Endowment is managed by external investment managers in accordance with the LCF Investment Policy Statement ("IPS"). The principle purpose of the IPS is to formulate guidelines for the prudent investment of the Endowment. The IPS establishes and communicates the Foundations' investment objectives and principle governance policies. The Foundations' primary investment objective is to earn a rate of return over the long term that preserves the real purchasing power of the Endowment's assets. The long-term average rate of return objective, as measured over moving 10 year periods, is expected to be 6.0% - 6.5%. The Foundation recognizes and acknowledges some risk must be assumed in order to achieve the long-term investment objectives of the portfolio, and there are uncertainties and complexities associated with investing in capital markets.



Five Year Review: 2012-2016




Positive financial markets combined with generous gifts contributed to the significant increase to total assets for a fifth consecutive year.





Investment Returns


The Foundation's financial stewardship strategy looks at a long term horizon to ensure legacies created by donors are respected and grant-making will continue in perpetuity. A combined focus on capital preservation as well as income growth has allowed for our continued success in both down and up markets. The 2016 total return is 7.8%. As of the end of 2016 we continued to track well at slightly over 6.0% against our long-term return objective of a total annualized nominal rate of return of 6.0%–6.5% over a 10 year moving average.


Total Contributions

In 2016, the Foundation received \$2.4M in new gifts (2015: \$4.4M). 14 new funds were established (2015: 11); the threshold for establishing a named fund begins at \$5,000 and varies with fund type.



Granting Activity


2016 continued to be the biggest year in the Foundations' history in a number of categories related to our community initiatives and granting, both in number of charities supported, number of grants issued, as well as in largest individual grant issued (\$377K). In 2016 our grants disbursements for charitable causes were \$3.4M (2015: \$3.6M). 478 grants supported 178 charitable organizations (2015: 470 supported 176).

Managed Funds & Registered Charity Funds (in millions)

In 2016, LCF continued in being a partner to other not-for-profit organizations and foundations with a mandate of improving the community. Our Managed Funds Program was established to support other Foundations that entrust LCF with the management of their endowed asset. Registered Charity Endowment Funds are established by charitable organizations to build endowments that provide secure sources of operating income to help ensure sustainability.





Unrestricted Endowed Assets

LCF through the continued support of our donors has established a growing unrestricted asset base, consisting of an Operating Endowment, to help offset administration and overhead costs and The Smart & Caring Community Fund, used to support the LCF Community Vitality grant program and other discretionary community initiatives. This trust in the LCF board and Staff has allowed LCF to be able to make increased and meaningful grants in the community.






Organizational Effectiveness

LCF continues to be focused on sound management and strong governance, pillars that support the achievement of goals in a healthy workplace where employees and volunteers work as a team and thrive, and where resources and expectations are aligned. Operating costs as a percentage of average asset value has been commonly used by community foundations as a benchmark of efficiency. Operating costs are impacted by the projects undertaken to support operations, the asset classes and structure of the investment management program, professional and

technical costs directly attributable to gift acceptance and charitable initiatives in the community. The benchmark for Foundations' of similar asset size to LCF are approximately 1.5%–2.0%. We continue to be a lean, mean, community-building machine!



2016 Award Recipients

Rainbow Youth Leadership Bursary
