COVID-19 POLICIES & PROCEDURES

ALL PROCEDURES AND POLICIES ARE SUBJECT TO CHANGE

WentworthCon maintains that the health and safety of our attendees, celebrity guests and staff are our number one priority as we navigate the COVID-19 pandemic and beyond. In an effort to make sure that our event is as safe as possible moving forward, we will be following the requirements of Federal/State/City mandates and enforcing COVID-19 safety policies and procedures for our 2022 events.

Our COVID-19 Policies and Procedures have been created with guidance from our celebrity guests and staff and are necessary in order to ensure the safety of all parties attending. Please understand that Australia has enforced strict protocols since the beginning of the pandemic and we must comply with guest requirements.

Here are the following **COVID-19 Policies and Procedures*** for the New Jersey Wentworth Convention scheduled for July 23-24, 2022:

REQUIREMENTS FOR ENTRY

ALL individuals attending must present a negative PCR/NAAT COVID-19 test result, which should be taken within **72 hours (3 days) of attending the convention**. Your negative COVID-19 test documentation needs to be directly from the healthcare provider that performed the test, and the test must be taken on or after **Wednesday, July 20, 2022**.

You can display your proof on your smartphone or present a physical copy, along with an appropriate government-issued ID matching the name on the documentation. Those younger than 18 may use a government-issued ID, birth certificate, social security card, school ID, or locally-issued ID.

All COVID-19 tests must be done by a certified lab or clinic, home tests will not be accepted. The test must be a lab PCR or NAAT test or a Rapid PCR test. Rapid Antigen tests will not be accepted. Whether you plan to attend registration on Friday, July 22, Saturday, July 23, or Sunday, July 24, you will need to provide this documentation to receive an entry wristband. For your reference, [here's a website for COVID testing sites in the State of New Jersey](#). **You are responsible for coordinating your own test and presenting the required documentation.**

Should your documentation not arrive in time for event registration, we will have a very **limited supply** of rapid tests available on-site for a fee of \$15, available at our discretion and while supplies last. These tests will only be available to those who attempted to take a PCR test within the required time, but did not receive their results. Proof of the test attempt will be required. We will not provide rapid tests to those who did not attempt to take a PCR test. **NOTE: By attending registration and attending the event, you are inherently agreeing that if you should fail any applicable screening test or fail to comply with the COVID-19 safety protocols, you will leave the event venue and furthermore, you agree that you will not be due a refund of event tickets and KClark Productions will not be responsible for any consequential damages as a result of your expulsion.**

Mask-wearing is optional for all attendees of WentworthCon.

Sanitizer stations will be placed throughout the convention area for public use. We ask that you be mindful of others, use hand sanitizer, and wash your hands with warm water and soap for at least 60 seconds while attending WentworthCon.

If you are feeling ill, please DO NOT attend.

PHOTO OPS, AUTOGRAPH SIGNINGS and MEET & GREETES

Photo Ops – Please note that special poses/hugs/kisses are not offered in the purchasing of a photo op. Please do not ask the guest for physical contact. The Guest will let you know what they are comfortable with as you approach them in the photo op. Some Guests will prefer no contact, some a handshake, and some will put their arm around you. We are placing these protocols in place under the guidance of the guests, and we need to respect their comfortability during these COVID times.

Round Table Meet and Greets - Depending on the requests made by individual celebrity guests, you may be required to sit at an appropriate distance from the guest and fans. The experience will remain intimate with only 10 fans in a session. Please follow all rules put in place by the guests and be respectful of boundaries.

Autographs – There will be no hugs, personalized video recordings, or photos/"selfies" during the Autograph session. You may bring your own items to be signed, a staff member will collect your item and pass it to the celebrity guest to be signed. Please follow all rules put in place by the guests and be respectful of boundaries.

Failure to comply with the above rules for experiences will result in expulsion from WentworthCon without refund. These safety protocols are being put in place by our guests for the safety of all. KClark Productions LLC will not be responsible for any consequential damages as a result of your expulsion.

COVID-19 and disease policy updates: State and local mandates change daily. We are and will continue to monitor any and all regulations and will post any changes in our policy as soon as possible on the event web page.

Disease and Illness Disclaimer: By attending WentworthCon, you recognize that disease and illness, including, but not limited to, the coronavirus (COVID-19) and the common cold, may be spread through interaction with other people. Our events may be attended by many people. If you do attend, you agree that you will take all possible steps to protect your health and the health of others attending the event. KClark Productions will not be held responsible for any consequential damages if you are asked to leave the event.
