  - a. County of Mendocino (Karen/Megan)—remodel for phase 2 at Live Oak Apartments continues to be delayed. Another 20 units expected to become available in the summer.

#### 2. Standing Committee Reports

- a. Strategic Planning (Dan)—nothing to report, haven't met
- b. Shelter & Solutions (Angelica)—absent, haven't met
- c. Coordinated Entry/Discharge Planning (Sage)—have adjusted/updated Coordinated Entry access points in the community. Committee is working on a simple flyer that should go out soon, correct drop-in times need to be determined. (Mendocino Coast Hospitality Center, MCAVHN, Building Bridges). Been exploring mechanisms in Coordinated Entry how we can transfer chronically homeless households from Permanent Supportive Housing to Rapid Re-Housing. People need to be connected to resources that will be appropriate for them. Coordinated entry needs should be decided both via standardized questions, but also qualitatively via case managers and service providers.
- d. Membership Committee (Veronica)—has not met for regular duties, was focused on governing board seats, looking for input from Strategic Planning Committee.
- e. HMIS / Performance Measurement (Brian)
  - i. 2022-03 CA-509 Brief Data Completeness Report Card (see attached)
  - ii. Seven tribal entities that had funding set aside for ESG-CV. Mendocino County has three of those entities: Northern Circle Indian Housing Authority, Manchester Bay of Pomo Indians, and Sherwood Rancheria. Adding to our mix. We are in a statewide spotlight on tribal engagement due to our high number of tribal entities.
  - iii. Subcommittee established to do lead review work. Helpers needed. HMIS cannot review itself. Preferable but not necessary for HMIS experienced users to participate in committee. This is not a huge time commitment nor are they Brown Act required. Melissa from HUD will be facilitating.

#### 3. Ad Hoc Committee Reports

- a. 2022 Point in Time (PIT) Count and Housing Inventory Count (HIC) (Veronica)
  - i. Due this Friday 4/29/22
  - ii. Working on data completeness, quality and HMIS export
  - Shifted modifiers to reflect current times, last update was ten years ago.
  - Moving forward, we'll be recommending that there be additional training and forethought that people be aware of how to engage with people in the various structure types.
  - Sage expressed that we have more information to speak to the skepticism typically expressed by the general public. Utilizing technology also increased confidence in the numbers.
  - Lake County does their PIT at 9 am, it might be worth considering in the future.
    Historically it was done so early (in part) because shelter guests leaving the shelter
    might be affecting the numbers, but now that HMIS can be leveraged for sheltered
    count, we can possibly start later.
  - iii. Staff will be meeting with Simtech to discuss next steps

- 2. **Recommended Action** to Approve Increasing Emergency Housing Voucher (EHV) Memorandum of Understanding (MOU) Recently Homeless Preference Points to 500 (Lisa)
  - a. This is on page 19 of the packet.
  - b. CDC board approved on contingent of approval of CoC.
  - c. This will allow us to stabilize the recently housed as well as provide stable income to the developers of the projects. It allows PSH to transition when they no longer need CM, it helps free up RRH funds.
  - d. This is challenging primarily because of the housing stock availability.
  - e. Sage moves to approve, Judy seconds.

- 3. **Discussion and Possible Action** of EHV MOU Language Regarding Section V.3-6 (Veronica/Megan) (See page 21 of the agenda)
  - a. For a client to receive EHV, the MOU assigns CoC to do the documentation for them (section 5). Intention is for CE system to assign each client to a specific agency to provide that support and case management to them. At this time, our CE system doesn't function in that way; oftentimes our CE clients don't get connected to anyone else in the CoC, front doors often don't have the capacity to take on everyone who walks in.
    - i. Discussion:
      - Sage: this is challenging for Building Bridges, with EHV not set up with supportive services attached. The fallout is that the housing navigators at Building Bridges are swamped. The amount of work is intense and there is no capacity to provide. It's to the point where we are no longer referring into EHV unless more supportive services could be set up. It is a similar challenge with PSH; EHV murkier. PSH might be a better fit for some. Not everyone has behavioral health needs, and some do not want those services. Staffing for specialty behavioral health services is low.
      - Natalie willing to offer help on behalf of Manzanita and Tapestry in whatever capacity they can.
      - Very low numbers on referrals to Landlord Liaison; utilize this service.
      - This in an eligible activity under the state HHAP Program. CoC needs to support direct service providers so that this work can be done.
      - Brian: There is a huge increase in funding because of CARES Act/COVID-19 that
        we do not have the agencies or the trained staff in the community to get the funding
        spent. It would take at least two years to spend it down. We don't know how long the
        funding is here for. This is a unique problem.
      - Judy: The biggest challenge is the lack of housing in our area.
      - Jacque: case managers train at the CoC level at the same time and hire them knowing that the outcome of the position is job experience (if no permanent

- employment occurs).
- Veronica: Napa uses Abode Services, can be attributed to their successful outcomes.
- Sage: What can we do to make the application process more doable for clients to complete without as much case management assistance?
- Discussion tabled for now. Please think of ideas for next meeting.
- 4. **Discussion and Possible Action** on Participation in CA 100 Day Challenge (Sage)
  - a. CA rolling out cohort 4 of Hundred-Day Challenge. This time it is getting communities that have already completed a Hundred-Day Challenge identify 2 people from each community to train on how to complete a Hundred-Day Challenge of their own without relying on the supports of Rapid Results. This model is useful for making a big impact on positive housing outcomes.
  - b. It starts 5/1/22. We choose two coach-trainees to submit to train how to lead the community through the Hundred-Day Challenge process.
  - c. We would need to make a commitment as a community whether we want to do this.
    - i. Jacque: Is there current work underway in the moment that would benefit from applying this methodology at this time?
      - Sage: What was successful that we had a captive audience, they were accessible
        because it was PRK so the hunting for people was taken out of the equation.
        Currently, we have shelters. How do we get them quickly out of shelters into
        housing? The other thought is around RRH is that a Hundred-Day Challenge may
        be doable in supporting that we are not just adding another thing in addition to the
        things we are already working on.
      - Brian: could combine the two populations; gives a specific focus target that does not add a whole new infrastructure. It is a great way to get the community to act quickly in getting people housed without the typical added steps.
    - ii. Is there anyone willing to step up or nominate someone else?
    - Dan: reality is that we should be focused on trying to maintain what we already have in a positive way moving forward.
    - Sage: lot of agencies whether having staffing challenges or not does not mean they have the capacity to be able to pull this off.
    - iii. Jacque wants to remind everyone that this group knows everything that those people know. The difference is that they've made a commitment to go fast and prioritize. If we do this work better together this might be even better than doing the challenge.
  - d. To summarize, we are deciding not to move forward with this.

  - b. This is the first year HUD has allowed CoC's to include Tribal Nations in Jurisdiction.
  - c. This is new info and Veronica is working back with the tribes but might not be able to include them in this year's registration.
  - d. If we were to move forward with them it would likely impact their ability to form their own CoC.

  - a. HCD has completed review of 2021 ESG BOS applications, awardees have been notified but not yet publicly posted
