## DISCRIMINATION AND DISPARATE TREATMENT DURING COVID-19

Hatred and fear spread just as easily as any virus during these unprecedented times. Across the nation, there are increased reports of hate crime and hate speech. Also, because the COVID-19 pandemic is disparately impacting communities of color and the poor, it is critically important that healthcare and critical resources be available to all. Our community must come together and support each other. The virus does not discriminate in whom it strikes. You should not be discriminated against in getting the healthcare you need to fight it.

#### **Hate Crimes and Hate Incidents**

**Hate Incident**: Non-criminal conduct motivated by bias against race, color, religion, national origin, ethnicity, sexual orientation, gender, gender identity or disability.

**Hate Crime**: When someone commits a crime that is motivated by bias against race, color, religion, national origin, ethnicity, sexual orientation, gender, gender identity or disability.

If you witness or are the victim of a hate crime, contact:

911, a nearby police officer, or your local police department to file a police report.

#### **Access To Health Care**

**Discriminatory Access to Care:** When a care provider rations care because of a patient's status in violation of federal and state legal protections.

- Decisions regarding how care is administered and to whom, must be based on biological factors related to the likelihood and magnitude of benefit from the medical resources.
- Factors that may NOT be considered in assessing the likelihood and magnitude of benefit from medical resources include, among other things: race, disability, gender, gender identity, ethnicity, ability to pay, socio-economic status, perceived social worth, perceived quality of life, immigration status, incarceration status, homelessness. These factors are irrelevant and CANNOT be considered when making choices regarding allocating resources for care.
- Crisis care provided at hospitals must be the best care possible considering the current circumstances and given their available resources.
