Students must be capable of moderate physical activity. An agency Class A uniform will be required dress on certain dates (business suit and tie if not assigned to uniform duty).

This course will end with a transition to live-fire where officers will solidify the tactics they learned over the course of the week.

ADVANCED TRAFFIC STOPS

This course will cover tactical skills and methods related to one of the most common tasks a police officer performs, patrol traffic stops. Officers will learn and reinforce techniques related to the "STOPS" training program and others during this course. The course will cover the following topics; vehicle stop positions, approaches, callbacks, escapes, high-risk or 'felony' stop tactics, principles of 'officer induced jeopardy' related to shooting into vehicles, low-light traffic stop tactics, and vehicle close-quarter combat principles. Officers will engage in realistic, force-on-force scenarios to address common deadly threats from inside and outside vehicles with non-lethal training weapons and ammunition. This will reinforce life-saving principles and inoculate them against some of the extreme stresses of violent, deadly force encounters. The final day will be a transition to live-fire where officers engage targets from inside a motor vehicle, through the windshield glass to learn about the effectiveness of such engagements. They will engage in other live-fire scenarios in, and around, a motor vehicle.

The student will be made aware that police investigations in cases of acquaintance rape should focus on evidence that establishes the absence of consent and/or the presence of force or threat, because this is the type of evidence necessary to overcome a consent defense. The student will be made aware of the importance of the Sexual Assault kit, process of evidence collection and Kentucky laws as they relate to sex crimes.

Beginning January 1, 2017, the council shall establish a forty (40) hour sexual assault investigation training course. By January 1, 2019, agencies shall have one (1) or more officers trained in this curriculum, as follows:

The course will explore values and how agencies of all sizes can achieve greater success through improving the quality of life of their officers as well as the service provided to their communities. The course will scrutinize institutional, occupational, and core values, and explain the importance of alignment of these values; moreover, the course will explain how values influence the officer's moral and ethical decisions. Furthermore, the course will examine the psychological types lacking integrity, the enemies of integrity, and the core virtues of policing. Interpersonal communications will be addressed with a focus on intent, content, listening, and other verbal and non-verbal responses. Additionally, three contemporary models of leadership, Servant, Transactional, and Transformational will be described with identification of the style most used with its rewards and limitations.
