The City of Pittsburg has embarked on an exciting and challenging process to update its General Plan!

The General Plan is a long-range planning document that is considered the City's "constitution" or blueprint, because it guides growth, traffic patterns, housing, and resource conservation. The General Plan is the City's guiding policy document for future development decisions related to land use, community design, mobility, economic development, fiscal sustainability, public services, and natural and historic resources. The City's General Plan will reflect community goals and values and serve the City for the next 20 years.

The City wants to hear from its residents, businesses, and employees to make sure that the General Plan addresses current issues of local concern and provides a vision for the future that is consistent with the desires of the community.

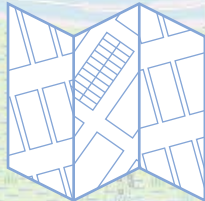

# WHAT IS A GENERAL PLAN AND WHAT DOES IT ADDRESS?

The state of California requires every city and county in California to adopt a General Plan, which is the local government's long-term blueprint "for the physical development of the city and any land outside its boundaries that bears relation to its planning." General Plans are divided into elements based on specific topics. There are seven mandatory elements: land use, circulation, housing, conservation, open space, safety, and noise. State law allows local governments to organize and format their general plans however they desire, as long as the required topics or elements are addressed. Cities can also choose to include additional elements, such as economic development or community health and wellness. The Envision Pittsburg General Plan is expected to address the following topics:



## Land Use, Urban Design, and Downtown

Establishes land use designations, patterns, and concepts that promote the community's health, happiness, and well-being, create a sense of place, ensure environmental justice, and contribute to high quality of life.



## Mobility

Guides decisions for how people of all ages and abilities can safely and efficiently get around the community—including by car, bike, walking, and transit. It will also consider new transportation technology and trends.



## Youth and Recreation

Ensures a wide range of parks and recreation services are provided to serve the community, with an emphasis on ensuring ample opportunities for youth-oriented activities, events, and places.



## Safety

Addresses natural and man-made safety hazards such as fires, flooding, seismic safety and geologic hazards, sea level rise, hazardous materials, aircraft, noise, and emergency operations and preparedness.



## Conservation and Open Space

Provides measures to protect and improve the City's natural, historic, cultural, and biological resources. Addresses the topic of local and regional parks, recreation and open space, including trails and scenic vistas.



## Economic Development

Provides tools and strategies to foster a strong and sound local economy, including goals and policies related to business retention and attraction, job creation, and Pittsburg's role in the regional economy.



## Growth Management

Addresses the City's capacity for growth and provides measures to ensure that the City's circulation system, infrastructure, and public services are planned and provided to accommodate development.



## Public Facilities and Services

Gives direction on community infrastructure and facilities and services including water supply, wastewater, flood control, waste and recycling, storm drainage and water quality, and public facilities.



## Community Health and Wellness

Articulates community health and wellness goals and policies including fair and equitable access to recreation facilities, healthy food, transit, and medical services and support.





## WHAT IS THE PROCESS FOR THE GENERAL PLAN UPDATE?

The Envision Pittsburg General Plan Update will take place over a two-year period, concluding in Winter 2020. The major steps in the Update process are as follows:

- 1 Document Existing Conditions - We Are Here!**  
Identify development patterns, natural resources, socioeconomic conditions, environmental constraints, and the regulatory environment for each general plan topic, such as land use, mobility, public facilities and services, conservation and open space, and safety.
- 2 Vision, Opportunities, and Land Use Alternatives**  
Identify the community's vision for Pittsburg's future, core values, and key opportunities and land use options. Address potential land use scenarios and the capacity of the City to accommodate anticipated growth.
- 3 Draft General Plan**  
Will comprise goals, policies, and actions that will guide future decisions related to land patterns, infrastructure, and services to ensure a high quality of life for residents and businesses.
- 4 Environmental Review**  
To analyze and minimize all potential environmental impacts, the City will prepare a Program-level Environmental Impact Report (EIR).
- 5 Adoption**  
The Final General Plan will be presented to the Planning Commission and the City Council at public hearings, with the City Council having the authority to adopt the document.

## GENERAL PLAN DOCUMENTS

As the General Plan is prepared, a number of major documents will be made available for public review and comment:

### Existing Conditions Report

Provides a snapshot of the conditions, trends, and regulations that are influencing the City today. It will focus on development patterns, natural resources, economic conditions, environmental constraints, and demographics.

### Issues and Opportunities Report

Provides a summary of the critical policy and program issues to be addressed in the General Plan. The report will present alternative approaches that can be used to address each issue. This document will be used by the City to provide direction on the focus of the General Plan.

### Land Use Alternatives and Capacity Report

Presents three different Land Use Map alternatives, and an analysis of the land use, circulation, fiscal viability, economic development, public services, and infrastructure effects associated with each alternative and ability of each alternative to accommodate planned growth.

### Draft General Plan

Contains the goals and policies that will guide future activities, services, and development in the city. It also identifies a full set of implementation measures that will ensure the policies are carried out.

### Environmental Impact Report (EIR)

Addresses California Environmental Quality Act (CEQA) requirements. The decision-makers will use it during their consideration of the draft General Plan to understand the potential environmental implications associated with it.

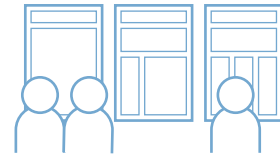
## STAY INFORMED! GET INVOLVED!

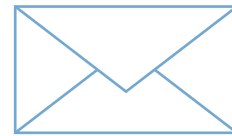
### Open Houses
