

DRAMATURGICAL NOTES

Macbeth is best known as a play about the violent actions of a mad king, but the Rebels of FCR want to show you that there is so much more to this story. At its core, *Macbeth* is a show about inheritance, legacy, and the dangers of limiting a person's experiences in the world to their ability to present proper versions of masculinity or femininity.

Setting *Macbeth* in the mafia in the 1920's places these issues under a microscope. Strict ideas about a man's role in 1920's America, especially within the hierarchical structures of organized crime, permeated familial and platonic interactions. Meanwhile, the emerging presence of the iconic "flapper" persona blurred the lines between male and female roles.

In January of 1920, the United States famously outlawed the sale, purchase, and consumption of alcohol with the 18th Amendment. This amendment launched the country into the "Prohibition Era," in which the profits of organized crime skyrocketed, and notorious criminals like Al Capone became household names. A notorious failure, which did more to boost the popularity of alcohol than to prohibit it, Prohibition was repealed in 1933 by the 21st Amendment.



OUR MISSION


"And when she is froward, peevish, sullen, sour,

Taming of the Shrew is an easy play to hate, from a feminist perspective; but it gets at least one thing right: when women are loud, when they are assertive, when they are argumentative, what are they but Foul Contending Rebels? It is for this exact reason we have adopted the name as our own: to create theatre that rebels, that argues, that fights back against what it is supposed to be.

The Foul Contending Rebels Theater Cooperative is invested in prioritizing the inherently rebellious nature of the female voice. We will be froward, peevish, sullen, and sour. We will not obey any wills but our own (not even the wills of Will himself).

We are not a Company, but a Cooperative. We are dedicated to inhabiting flexible roles, sharing thoughts and creativity, and breaking down barriers between participants in the creative process. This means we are all actors, directors, producers, and designers, we share responsibilities and authority equally, and we will come into every production ready to learn about theater, and about ourselves.

FCR exists because we love theater, because we want to be a part of theater created, organized, and run by young artists, and to create a space for aspiring theater professionals to be at the forefront of the productions they work on and not have to answer to antiquated ideas of what theatre can and should be. We aim to infuse our productions with the energy and the innovation that belong intrinsically to Youth.




