CONDITIONS OF ENTRY

- 1) No entry will be accepted without payment of the required Entry Fee
- 2) Cheques or Money Order should be made payable to "Commercial Club (Albury) Ltd" Billiards & Snooker Club
- 3) To be eligible, entrants must be registered and in good standing with an affiliate of ABSC.
- 4) The draw will provide for play to commence at **9.00am on Friday**, **17 April 2020**. The draw will be conducted on **Friday 10 April 2020**. There will be no seeds and will be a random draw.
- 5) Play will continue on **Saturday**, **18 April 2020 at 9.00am** until the final 16 players are determined. There will be a Consolation Plate depending on numbers and if time permits Entry Fee \$20.
- 6) All Last 16 matches will be played on **Sunday**, **19 April 2020** commencing at 9.00am.
- 7) All matches will be Best of 5 frames. If time permits, the Final will be best of 7 frames with a referee supplied.
- 8) **Dress Rules are**: collared polo shirt with minimal advertising, tailored dark slacks and dark dress shoes.
- 9) Prize money extends to all qualifiers in the round of 32 and will be paid in cash up to a limit of \$450 and any balance owing will be paid by crossed cheque and presented following the Final or mailed from the Commercial Club on Monday 20 April 2020
- 10) There will be **NO REFEREES FOR THIS TOURNAMENT. ALL LOSING PLAYERS** in each round will be required to referee the next match. For the first round of the Tournament, qualified people will roam the snooker room
