  - d. Embassy Certificate of the Sponsorer (Certificate from the Consulate).
- The Candidate should also bring/ upload the following certificates, if applicable
  - a) SC/ST Certificate issued by the competent authority and should be in English or Hindi language. Sub caste should be clearly mentioned in the certificate.
  - b) OBC certificate issued by the competent authority. The sub-caste should tally with the Central List of OBC. The OBC candidates should not belong to Creamy Layer. The OBC certificate must be in the format as mentioned in the prospectus.
  - c) Disability Certificate issued from a duly constituted and authorized Medical Board for 21 Benchmark Disabilities as per the Rights of Persons with Disability Act,2016. No other PwD certificate, issued by any other Authorities/ Hospital will be entertained.

## Fee Structure:

### Course Fees (to be paid during Admission):

- Amount to be paid at the time of Admission (Rs):1st year Tuition fee
- The Amount of Fee to be deducted on reallocation of seat to the candidates in 2nd/3rd round of Counseling: Rs.30,000/-
- The amount of fees to be reimbursed in case candidate resigns during or after Stray Vacancy Round of counseling: The full course fee amount will be forfeited

### Fees for Hostel Admission:

1. Hostel fee (PG) -
  - a. Non-AC single occupancy: Rs. 160,000 / Rs. 100,000
  - b. Non-AC double occupancy: Rs. 100,000 / Rs. 75,000
  - c. Non-AC four occupancy: Rs. 75,000
  - d. AC single occupancy: Rs. 2,40,000/Rs. 1,80,000
  - e. AC double occupancy: Rs. 1,50,000/Rs. 1,20,000

### Other Fees:

1. Institute Caution Money - Rs 5,000/- (one time and refundable)
2. Hostel caution money- Rs 5,000/- (one time and refundable)
3. Mess- Rs 36,000/- per annum
