#### **Site Background**

The Site consists of ±31 acres at 1611 Talleyrand Avenue on the west bank of the St. Johns River in the predominantly industrial port of Jacksonville. From 1893 to 1978, Kerr-McGee and its predecessors used the Site to manufacture, formulate, package, and distribute fertilizers, pesticides, and herbicides. Site contaminants—primarily pesticides and metals—are present in soil, sediment, and groundwater at concentrations that may pose a threat to human health and the environment.

#### The Multistate Trust

The Multistate Trust is a private, independent entity created as part of a bankruptcy settlement to own, investigate, and clean up the Site and facilitate safe, beneficial Site reuse and long-term stewardship.

The Multistate Trust performs its Site-related work under EPA oversight in consultation with the Florida Department of Environmental Protection (FDEP). EPA and FDEP both must approve property sale or other disposition. Site cleanup funds were paid by Kerr-McGee and other companies responsible for Site contamination.

Greenfield Environmental Multistate Trust LLC is the court-appointed Trustee of the Multistate Trust. The Multistate Trust owns and manages hundreds of contaminated, former Kerr-McGee sites in approximately 30 states. Visit multistatetrust.org.
