**A.  Enroll in the 500-hour Traditional Thai Massage Program:**

**Intensive Tracks: Full-Time or Part-Time**

5 days a week, 6 hours per day (approximately 4.5 months to complete the program from start date)

1. **Period Covered:** This Enrollment Agreement covers the full 500-hour Traditional Thai Massage program. The student must complete the entire full-time 500-hour program within nine months from the first day of class. *If the student does not complete the entire program within nine months, then an additional fee of \$5.00 per course hour will be charged to the student for all classes taken after nine months from the first day of class.*

*The entire 500-hour program must be completed within one year of the first day of class (excluding any approved leave of absence).* A certificate will be issued upon successful completion of the entire 500- hour course.

2. **Payment Options:** Bodhi Panya Institute does not have a financial aid program. However, by choosing one of our payment plans you may pay as you study at the lowest cost for classes. Bodhi Panya Institute does not participate in Federal

or State financial aid programs; however, if you do obtain such financial aid it is your responsibility to follow the stated repayment stipulations of the loan agency.

**Payment Option 1: Pay in full**

**Total Tuition and Fees : \$6,775** (\$7,250 tuition plus \$250 registration fee less: ten percent (10%) discount of tuition (\$725) for payment in full at the time of enrollment. Payment by check, cashier's check or cash. Please note: credit cards are not accepted for payment in full option.

**Payment Option 2: Five monthly installments**

**Total Tuition and Fees: \$7,500** (7,250 + \$250 registration fee). The \$250 registration must be paid at the time of registration. Tuition is paid in monthly installments over five (5) months - the first payment is \$1,450 and is payable on (mm/dd/yy)\_\_\_\_\_. Thereafter, four (4) monthly installment payments each in the amount of \$1,450 will be payable on the 1<sup>st</sup> day of each month. All payments must be made on or prior to completion of the 500-hour program.

**Installment Payment Plan:** As long as payments are made on time, there are no fees for Payment Option 2 (installment payment plan). Students who miss a payment deadline will be charged a \$50 late fee for each past due payment. When all fees are paid in full all certificates and transcripts will be available to the student. If a payment plan has been agreed between Bodhi Panya Institute and a student and the student fails to complete the course, any outstanding course fees will still be payable.

**Payment Option 3: Flexible Schedule~ Pay As You Go!**

With the flexible schedule, a student can pay for each class in the 500-hour Traditional Thai Massage program separately (i.e. Basic Traditional Thai Massage 42-hr, Thai Aroma Massage 30-hr, Swedish Massage 36-hr, etc.) as classes are taken. Students pay \$16.00 for each class hour for a particular class, payable in full on or prior to the first day of that class plus a one-time \$250 registration fee payable on or prior to the first day of class.

1. **Period Covered:** Students using the flexible schedule for payment are required to complete the full 500-hour program within one year of the first day of class (excluding any approved leave of absence).

2. **Enrollment and Payment:** A student may choose to enroll in individual classes (i.e. Traditional Thai Massage, Thai Aroma Massage, Swedish Massage, etc. ) in the 500-hour Traditional Thai Massage Program.

**Total Tuition and Fees:** Registration fee \$250 plus \$18.00 for each class hour, payable on or prior to the first day of class. \*Textbooks and class materials are included.

As an example, the Thai Aroma class is 30 hours. A student would pay \$540 on or prior to the first day of class to attend this class (\$540: 30 hours multiplied by \$18 per class hour).

Fees may be paid by cash, by check/money order payable to Bodhi Panya Institute or by credit card – please contact the School Administrator if you wish to pay by credit card.

***It is the sole responsibility of the student to check with the California Massage Therapy Council or other licensing agency to determine if the class hours and courses completed by the student at another school of massage combined with the class hours and courses completed at Bodhi Panya Institute are sufficient to satisfy the education requirements of the California Massage Therapy Council or other licensing agency.***

A certificate will be issued to the student for the number of class hours successfully completed in the 500- hour Traditional Thai Massage Program.

3. **Tuition and Fees:** Tuition and fees cover registration, all course tuition, textbooks and class materials.

**ADDITIONAL TERMS AND CONDITIONS**

- 4. Location of classes: Classes will take place at 38 Bryant Street, Suite 2, San Francisco, CA 94105 and at 480 2nd Street, Suite 200, San Francisco, CA 94107.
- 5. Schedule: Please check the daily schedule for each class.
- 6. Student's right to cancel. Cancellation notices must be in writing.

*Admission Rejection.* An applicant rejected for admission is entitled to a refund of all monies paid, including the registration fee.

*Right to Cancel.* A student has the right to cancel the Enrollment Agreement and obtain a refund of all charges paid through attendance at the first class session, or the seventh day after enrollment, whichever is later. "Enrollment" is defined as the date that the Enrollment Agreement is signed by the student.

*Written Notice Required.* Cancellation will occur when the student gives written notice of cancellation to the School President or the School Administrator.

*Written Notice Can Take Any Form.* The written notice of cancellation need not take a particular form, and however expressed, is effective if it states that the student no longer wishes to be bound by the Enrollment Agreement. A signed and dated notice of cancellation may be given by mail, hand delivery, or overnight express courier (FedEX, UPS, etc.).

*Effective Date of Written Notice.* If the cancellation is in writing, it is effective on the date of personal delivery or, if mailed, on the date postmarked. Bodhi Panya Institute ("BPI") shall refund any consideration paid by the student within forty-five (45) days after BPI receives notice of cancellation.

*Return of Equipment.* Students who received equipment from Bodhi Panya Institute must return any equipment received at the same time they deliver a written notice of cancellation to BPI.

*Student Loans.* If a student obtains a loan, the student will have the responsibility to repay the full amount of the loan plus interest, less the amount of any refund. If the student properly cancels the Enrollment Agreement and the student receives funding from a third-party source, the student is entitled to a refund of the money not paid from the third-party source. In the case of third-party source refunds, the refunds will go directly to the third-party source. If the student has received federal student financial aid funds, the student is entitled to a refund of the money not paid from federal student financial aid program funds.

7. Default on Student Loan. If a student defaults on a federal or state loan, both of the following may occur: (i) the federal or state government or a loan guaranty agency may take action against the student, including applying any income tax refund to which the person is entitled to reduce the balance owed on the loan and (ii) the student may not be eligible for other federal student financial aid at another institution or other government financial assistance until the loan is repaid.

8. Right to Withdraw; Refunds. Under California law, you have the right to cancel this Enrollment Agreement and obtain a refund of all tuition and fees paid (less the STRF fee) through attendance at the first class or the 7th day after enrollment and, after that you may withdraw from a course and receive a pro-rata refund for the unused portion of tuition and other refundable charges. Students who exceed 60% of the total hours of instruction shall not be entitled to a refund. Eligible withdrawing students will be entitled to a refund, based on the following example:

When Bodhi Panya Institute asks you to leave the program:

- *Attendance:* missing twelve or more class sessions results in expulsion. Tuition and fees paid by the student will be refunded in accordance with the refund policy stated above.
- *Non-Completion of Course:* students failing to complete the course will not receive any refund of tuition or fees.

• *Disruptive Behavior*: regular behavior found disruptive by teachers and fellow students may result in expulsion. Tuition and fees paid by the student will be refunded in accordance with the refund policy stated above.

*Full Refund to Student*: Bodhi Panya Institute reserves the right to cancel courses due to under-registration and to offer places in class for a later date or to discontinue the program in its entirety. If a program is cancelled, Bodhi Panya Institute will make a full refund of all charges. All refunds will be paid within 45 days of the date of withdrawal or cancellation.

9. Student Tuition Recovery Fund. The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if you are not a California resident, or are not enrolled in a residency program.

*Keep a Copy of Your Agreement*. It is important that prospective students keep a copy of this Enrollment Agreement, contract, or applications to document enrollment: tuition receipts or canceled checks to document the total amount of tuition paid. Such information may substitute a claim for reimbursement from the STRF, which must be filed within one year of the Bureau for Private Postsecondary Education's service to the student of their rights under the STRF, or if no notice of rights are reserved to the student, within 4 years of the institution's closure.

#### 10. NOTICE CONCERNING TRANSFERABILITY OF CREDITS AND CREDENTIALS EARNED AT OUR INSTITUTION.

The transferability of credits you earn at Bodhi Panya Institute is at the complete discretion of an institution to which you may seek to transfer. Acceptance of the certificate you earn in the 500-hour Traditional Thai Massage program is also at the complete discretion of the institution to which you may seek to transfer. If the certificates that you earn at this institution are not accepted at the institution to which you seek to transfer, you may be required to repeat some or all of your coursework at that institution. For this reason, you should make certain that your attendance at this institution will meet your educational goals. This may include contacting an institution to which you may seek to transfer after attending the Bodhi Panya Institute to determine if your certificate will transfer.

#### 11. Recognition of credits transferred from other institutions

Bodhi Panya Institute has not entered into an articulation or transfer agreement with any other school, college or university and does not accept transfer credits from any other educational institution.

If a student has completed class hours at another massage school approved by the California Massage Therapy Council ("CAMTC"), the student must request a transcript from that school along with the transcript of hours completed at Bodhi Panya Institute when he or she submits an application for a certified massage therapist with the CAMTC. CAMTC will evaluate the transcript from Bodhi Panya Institute along with the transcripts of any other CAMTC-approved massage schools attended by the student to determine if the student meets the CAMTC education requirements for a certified massage therapist. If a student has attended more than one massage school it is the student's responsibility to determine if the hours completed at Bodhi Panya Institute plus the hours completed at another massage school meet the education requirements of the CAMTC.

#### 12. Notice.

YOU MAY ASSERT AGAINST THE HOLDER OF THE PROMISSORY NOTE YOU SIGNED IN ORDER TO FINANCE THE COST OF THE EDUCATIONAL PROGRAM ALL OF THE CLAIMS AND DEFENSES THAT YOU COULD ASSERT AGAINST THIS INSTITUTION, UP TO THE AMOUNT YOU HAVE ALREADY PAID UNDER THE PROMISSORY NOTE.

Agreement, you authorize Bodhi Panya Institute to publish photographs and/or videos taken of you, and your name, for use in its printed publications, social media, and website, without payment or other consideration. Further, you agree to hold harmless, release, and forever discharge Bodhi Panya Institute from all claims, demands, and causes of action which you may have by reason of this authorization.
