Current rates for rentals of the Ted Blum Somerset County 4-H Center are as follows:

We offer half day rentals (up to 6 hours, including set up/take down)

Or full day (6+ hours in one day)

	Half day	Full day
Large Gym	\$250	\$500
Kitchen	\$150	\$200
Green Room	\$100	\$150
Blue room	\$100	\$150
Red room	\$100	\$150
Yellow room	\$100	\$150

Entire building rental for a full day would be \$1,200 and \$700 for a half day.

Building Superintendent will be \$22.50 per hour.

**NO GAMES OF CHANCE FOR ANY NON 4-H GROUPS ALLOWED. ALCOHOLIC BEVERAGES ARE NOT ALLOWED ON THE PREMISES AT ANY TIME AND NO SMOKING IN OR 50 FT AROUND THE BUILDING.**

A Certificate of Liability Insurance is required for rentals to outside groups. The certificate of liability must have the Somerset County 4-H Association named as additional insured and carry \$1,000,000.

Building and Grounds meets on the 2<sup>nd</sup> Tuesday of the month (no meetings June, Aug and Dec) All requests are subject to Building and Grounds approval at one of our monthly meetings. Please note the timing of our meetings while filling out your application.
