### About TWF

Texas Water Foundation (TWF) is a 501(c)(3) non-profit organization established in 1998 to expand public awareness among Texans regarding the vital role water plays in our daily lives. Under the leadership of a distinguished Board of Directors, TWF adopted a <u>new strategic plan in</u> 2019 with the objective of leading Texas into a sustainable water future. TWF continues to play a vital role in the water dialogue in Texas, while building new programs in water leadership, policy, and education.

As part of our policy program, Texas Water Foundation advocates for a sustainable water future by ensuring that water policies are well-designed, well-considered, and effective in addressing water issues that meet the needs of Texans, the economy, and our environment. TWF works to advance strong, well-informed deliberations to produce better policies. Where TWF does not advocate for specific policies, we seek to identify the range of policy options available and ensure their implications are well-explained and understood by decision makers and the public.

### **About the Position**

The Policy Program Manager will work with the CEO to effectively plan and implement TWF's policy program. A successful Program Manager will work with the CEO to think strategically about current water policy issues in Texas, and how TWF can help to inform the dialogue around those issues.

- Work with CEO to participate in and document state and federal water policy changes
- Support the organization and facilitation of the Water Grand Challenges
- Identify networks of partners to build policy coalitions
- Create timely, relevant public outreach messages, policy comments, and issue briefs that reflect TWF's policy strategies
- Design, create, and manage a database of relevant contacts to distribute timely policy information
- Produce annual policy landscape brief
- Manage Water Day at the Capitol
- Update TWF's water resource library
- Work with web developers to improve online resources for decision makers
- Maintain connections with the research community and manage any contracts with research institutes
- Facilitate stakeholder meetings on water policy issues

- Support fundraising efforts for Texas Water Foundation
- Manage consultants and related contracts
- Supports developing and deploying inclusive, just, and equitable advocacy strategies
