About the 21st Hawai'i International Summit

Summit Description and Goals

The 21st Hawai'i International Summit brings together the latest research on prevention, assessment, and intervention techniques concerning various aspects of trauma and maltreatment across the lifespan, as well as the long-term effects if left untreated. Plenary and breakout sessions will discuss various types of child, adolescent, and adult/elder trauma, the dynamics of maltreatment and trauma at home or in the community, and the psychological, behavioral, and neurodevelopmental effects. Nationally and internationally recognized presenters and local practitioners assemble to discuss the latest research, assessment methods, interventions, and prevention strategies for those who have been traumatized, abused, and/or victimized. Application of current research information and practical techniques, along with a focus on trauma-informed care, healing-centered practices, and cultural perspectives are emphasized throughout this Summit.

Objectives

- Identify current state-of-the-science research and practice concerning child, adolescent and adult/elder trauma and maltreatment
- Explain the dynamics and overlap of different types of trauma and maltreatment
- Identify the effects of early trauma on the long-term functioning of children, adolescents, and adults and elders
- Improve skills and techniques for helping children, adolescents, adults/elders, and families recover from various types of trauma and maltreatment
- Identify issues and strategies for preventing abuse and neglect
- Enhance understanding of trauma-informed and healing-centered approaches and practices

Continuing Education & Specialty Certifications

Earn up to 20.5 Continuing Education Credits

The Summit is approved to offer up to 20.5 hours of continuing education for Psychologists, Counselors, Marriage and Family Therapists, Social Workers, Attorneys, Certified Prevention Specialists, Victim Advocates, Substance Abuse Counselors, and many more. There is an opportunity to earn up to an additional 15 hours of continuing education credit by attending one of our Affiliated Trainings on April 5th or April 7th, 2024. Additional CE accreditation may be available – due to accreditation procedures, we are prohibited from advertising prior to approval. CE credits approved by California agencies are accepted in most states. Different sessions meet many licensure requirements for continuing education credits for child custody, domestic violence offender treatment, and child sexual abuse.

The Institute on Violence, Abuse, and Trauma (IVAT) is approved by the American Psychological Association to sponsor continuing education for psychologists. The Institute on Violence, Abuse, and Trauma (IVAT) maintains responsibility for this continuing education program and its content. The California Board of Behavioral Sciences (BBS) now accepts American Psychological Association continuing education credit for license renewal for LCSWs, LMFTs, LPCCs, and LEPs. The Institute on Violence, Abuse, and Trauma, #1857, is approved as an ACE provider to offer social work continuing education by the Association of Social Work Boards (ASWB) Approved Continuing Education (ACE) program. Regulatory boards are the final authority on courses accepted for continuing education credit. ACE provider approval period: 7/18/2023 – 7/18/2024. The Institute on Violence, Abuse, and Trauma has been approved by NBCC as an Approved Continuing Education Provider, ACEP No. 7385. Programs that do not qualify for NBCC credit are clearly identified. The Institute on Violence, Abuse, and Trauma is solely responsible for all aspects of the programs. The Institute on Violence, Abuse, and Trauma (IVAT) is approved by the California Board of Registered Nurses to offer continuing education for nurses (CEP #13737). The Institute on Violence, Abuse, and Trauma (IVAT) is approved by the State Bar of California to offer Minimum Continuing Legal Education (MCLE) for attorneys (#11600). The Institute on Violence, Abuse, and Trauma (IVAT) is approved by the California Consortium of Addiction Programs and Professionals (CCAPP) to sponsor continuing education for certified alcohol and drug abuse counselors (Provider #1S-03-499-0223).

IVAT Specialty Certifications

Summit sessions meet many of the training requirements for IVAT Specialty Certification Programs. Specialty certification assures the consumer that specialists have successfully completed the educational, training, and experience requirements of the specialty, and that their expertise has been objectively reviewed and documented.

Specialty Certification in Domestic Violence Offender Treatment

Includes training and experience in working with both male and female intimate partner violence offenders to understand the dynamics involved in intimate partner violence and typologies of domestic violence offenders.

Specialty Certification in Child Custody Evaluations

Includes an understanding of the issues of child development, parenting abilities, and issues, best interests of children, assessment techniques in general, and specifically regarding child custody cases. The dynamics of legal, forensic, and mental health issues are included.

Specialty Certification in Trauma Care

Includes an understanding of the various forms of trauma, short-and long-term effects of trauma, and assessing and treating adults and/or children who have experienced both simple and complex trauma. The dynamics of post-traumatic stress disorder are included.

Specialty Certification in Child and Adult Maltreatment (CAM) (Formerly known as CAST/CAAST)

Focuses on experiential, interdisciplinary, ethical, and culturally sensitive content that provides professionals with a common knowledge base for responding to child and adult maltreatment. This certification focuses on development and understanding of the numerous factors that lead to child and adult maltreatment and the existing responses to child and adult maltreatment.

Specialty Certification for Family Court Professionals

Innovated specialized training for family court lawyers, mental health professionals, and child custody evaluators. Requires some previous experience and/or training in areas of domestic violence and/or child maltreatment in the last five years.

Post-Graduate Certification in Child Trauma and Protection: Stop the Silence® - A Department of IVAT, in partnership with The University of Applied Research and Development (UARD), accredited in the United Kingdom (UK), now offers a Post Graduate Certificate in Child Protection as a stand-alone program, or the credits can be used toward achieving a Master's in the field.. The program is a unique opportunity to get important, fundamental information at one's own pace provided by experts in the field of adverse childhood experiences (ACEs), for a fraction of the cost of other programs, and in as little as three months for the certificate and 12-24 months for the Master's. The focus includes prevention, treatment, mitigation, and policy considerations regarding child sexual abuse, physical abuse, psychological abuse, and other traumatic events. Partner Certification

MEGA² Specialized Risk Assessment Training (Assessing Sexually Abusive Youth, Ages 4-19 Years)

MEGA² is a tool for assessing risk for coarse sexual improprieties, and/or youth who are sexually abusive in youth ages 4-19 years. MEGA² is applicable for adjudicated or non-adjudicated males, females, and transgender individuals, including youth with low intellectual functioning. Robustly anchored in scientific methods and tested on over 4,000 youth international (largest validation studies in its field), MEGA² is state of the art and unique. It provides a comprehensive individualized risk assessment report according to age and gender. MEGA² can also follow changes in the youth's risk level over time (an outcome measure). This training provides certification on how to administer the assessment, as well as how to interpret and apply the MEGA² findings.

Plenary Speaker: Ernestine Briggs-King, PhD, serves as the Associate Director of Diversity, Equity, and Inclusion and Network Relations and the Co-Director of Data and Evaluation Program for the UCLA-Duke National Center for Child Traumatic Stress. She also serves as the Director of Research for the Center for Child and Family Health and is President for the American Professional Society on the Abuse of Children (APSAC). She is a clinical/community psychologist, Associate Professor with tenure, and Director of Equity, Diversity, and Inclusion in the Department of Psychiatry and the Behavioral Science, Duke University School of Medicine. Dr. Briggs-King's professional expertise focuses on implementation, dissemination, and evaluation of evidence-based treatments; child traumatic stress; resiliency; mental health disparities and inequities, quality improvement, and increasing access to care for underserved youth/adolescents.

Plenary Speaker: Penny Martin, Education Specialist, was born and raised on the island of Molokai in the ahupua'a of Kalama'ula on her grandmother's homestead, where she learned many "life lessons" that still guide her today. She attended Kamehameha Schools Kapalama campus and Hastings College in Nebraska. For over 20 years she worked as an outreach educator and tester/counselor for the Maui AIDS Foundation. Many of those she served came from a place of abuse and violence. From 1992 till present she continues to do outreach education as a cultural-based environmental educator. One of her greatest opportunities came in 1976 when she was invited to sail on Hokulea's maiden voyage from Tahiti to Hawai'i as one of two wahine to do so for the first time in over 200 years.
