## HISTORIC PRESERVATION

### Partnering with AARCH and Historic Saranac Lake

The preservation and conservation of the island's historic buildings and maintaining the Adirondack culture through educational programs for all visitors are key components to FEI's vision. The Eagle Island Great Camp was built in 1903 by former New York State Governor and U.S. Vice President Levi Parsons Morton. Its buildings were designed by William L. Coulter, preeminent architect of the Adirondack Great Camps.

To this end, FEI is partnering with Adirondack Architectural

Heritage (AARCH) and Historic Saranac Lake.

AARCH is the non-profit historic preservation organization for New York State's Adirondack Park. AARCH was formed in 1990 to promote better public understanding, appreciation and stewardship of the Adirondacks' unique and diverse architectural heritage.

Historic Saranac Lake is a not-for-profit architectural preservation organization that archives and presents local history from its

center at the Saranac Laboratory Museum.

An early step will be to hire a historic preservation architect to properly assess the buildings and develop a renovation plan with cost estimates. With such a plan we are hopeful that there is grant funding available

Michele Racciopi, Eagle Island alumna and long-time supporter of FEI will be working closely with Howie Kirschenbaum of AARCH and Mary Hotaling of Historic Saranac Lake on this restoration committee.

Fundraising began in earnest and over \$15,000 was raised.

## FUNDRAISING UPDATE

### Over \$220,000 raised for renovations

Once again the friends and alumnae of Eagle Island have heeded the call. In just one month over \$220,000 was raised. With these funds we can begin preparations as the new owners of our island home. We have the island back. Now we will become stewards of its future. What is it about this place that

brings tears to the women who once lived here? What memory warms your heart?

It is estimated that it will take \$1.5M to provide the infrastructure (sewer, water, electrical) and building renovations (roofs, structures, boathouse) necessary to become a fully operational camp.

About 180 donors raised \$220,000. If you have not given yet please consider it as we begin to plan for 2016 and beyond. Friends of Eagle Island is seeking financial support from individuals, foundations and organizations that have similar visions and a passion for

preserving history and educating future generations through the out-of-doors.

She served as Chair, 2003-2015, of the Livingston Open Space Trust Fund. 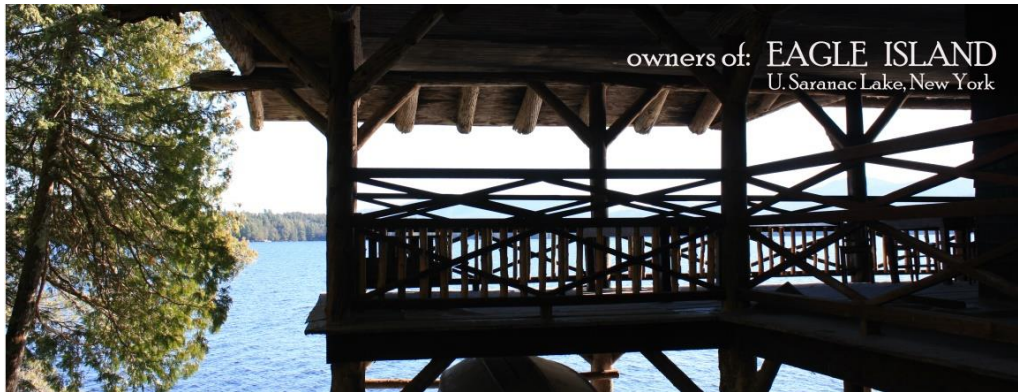
### TREASURER
