CURRENT WORK AND SUMMER 2016

Busy Season

The winter months have given the Friends an opportunity to develop detailed next steps for Eagle Island. We are making progress on the restoration and repair plans by working with our engineers and historic preservation architect. More definitive evaluations will be forthcoming now that ice is out and our consultants can get to the island safely.

As you all know, the National Historic Landmark buildings, along with the ancillary buildings, need repair and, in some cases, replacement of roofs, both to preserve the structures and provide a safe and comfortable environment for visitors. In addition, the electrical, water and/ septic systems need to be upgraded. Activity will begin soon to address the needed repairs and upgrades

upon obtaining the proper permits where needed.

Ice out has also allowed us to get a closer look at our boats. Many of you may remember the Ark which was a reliable vessel to ferry folks to and from the island for many years. You can now see the Ark at Spencer Boat Works for sale. We had to part with this piece of nostalgia for something more efficient. Recently, we were able to purchase a late model pontoon boat that will be used to ferry volunteers, contractors, consultants, supplies, and the occasional guest to the island this summer.

Volunteers have been signing up for days, weeks and weekends to help get Eagle Island back in shape. Anyone interested in signing up should fill out the form (or email or call) so that we can have a

A Busy Committee

The FEI Grants Writing Committee, comprised of Jane Evans, Paula McGovern, Lora Myers, Michele Racioppi, Tomoko Werbe, Cindy Woolworth, Chris Wubbolding, and Carol Bradof, Chair has met regularly since December.

We have composed "master" letters of information--for those foundations that pre-select their grantees- and "master" letters of intent for those foundations which accept applications. Four grant applications have been completed and submitted with at least three in progress.

Our committee is evaluating and categorizing foundations according to our immediate needs. For example, historic preservation grants are a higher priority now than those which support camperships or camping equipment. We also look forward to the more detailed costs estimates that will soon be forthcoming via the engineer's report regarding electric, water, and sewer expense sewer expenses as well as detailed expense estimates related to restoring the historic buildings themselves.

RECENT PURCHASES

A Van and a Pontoon Boat

Our overall \$1.5m budget included the purchase of a truck for the mainland and a transport vessel to ferry supplies and people to and from the island. These two items are vital to efficient operations this summer and in the future. We were very fortunate through our new relationship with the Boy Scout Council of Northern New Jersey that owns and operates the nearby Floodwood Mountain Scout Reservation to purchase a 15 passenger van for \$5K. This vehicle will serve a dual purpose of hauling construction materials and as a transportation vehicle once camp is in operation. Our second purchase was a late model gently used pontoon boat. This much needed vessel will provide transportation for approximately 12 passengers and a more effective transport of supplies. We are currently looking for a donor to fulfill this \$20k expenditure and have the opportunity to name the boat! Both expenditures were within budget. LAND USE DISCUSSIONS

One of the most important activities in the past few months has been pursuing with the Town of Santa Clara zoning and permitting matters. The "group camp" use is not been a permitted use under Santa Clara's land use code for quite a few years. The Girl Scouts were able to maintain it as a group camp year-to-year through continued use. When the Girl Scouts discontinued Eagle Island use as a youth camp for many years and made no request to the Town to preserve the ability to reopen the camp for a subsequent owner, FEI found itself in the position of not owning the property and thus having no ability to make such a request of the Town. Now that we own Eagle Island, FEI has been in discussions with the Town of Santa Clara and have requested that they consider adopting an amendment to its Land Use Code.

In turn, the Town asked Friends to reach out to the local community for support of our efforts. FEI has begun that process and has already received an outpouring of letters of support and encouragement. Indeed, FEI has welcomed the opportunity to obtain community input. In early April, FEI held an informal discussion at Historic Saranac with a number of community members and has plans to host other informative presentations introducing FEI to the community and to openly discuss our plans and address concerns. FEI is also pleased to be invited and to

participate in the upcoming USLA Annual Membership meeting on July 9th and looks forward to meeting more of our neighbors on the lake. Upcoming events will be advertised through the USLA website and other media outlets.

This process of obtaining input from the community has been very helpful in identifying, dispelling, and addressing some concerns raised by some homeowners in the area. One example of a concern is that jet skis and PWC might become part of Eagle Island programming. That will not happen. Eagle Island will continue programming that embraces nature and has low environmental impact, which means NO jet skis or PWC.

Another concern that a few lakeshore homeowners have raised is the possible excessive noise in the evening from the Mariner Boathouse, particularly given its location on the eastern shore of the island. Although specific programming and uses are not finalized, FEI will ensure that evening activities in that building will be limited to the earlier hours; the Main Lodge and Dining Hall, both of which are set back from the lake and protected by trees, will be designated for any group evening activities.

Eagle Island is and will remain a rustic destination, with activities which encourage guests to slow down and enjoy the natural and historic surroundings.

The 2016 Statewide Preservation Conference

Janet Trombly represented Eagle Island recently this statewide conference in Albany. She attended workshops and answered questions at the display table that AARCH so generously shared. Trudy Waddell and her husband Bill also attended some of the sessions and all three enthusiastically promoted Eagle Island to the historic preservation community. This annual

conference moved to the Capital Region to mark the 50th anniversary of the National Historic Preservation Act (NHPA). The theme **Preservation50: NYS** is part of the nationwide Preservation50 effort, to celebrate, learn from, and leverage the NHPA's first five decades to assure historic preservation's vibrant future in America.

ERNA SCHNEIDER HOOVER: A LEGACY ALUM

Erna Schneider Hoover spent six summers at Eagle Island Camp (EIC) beginning in 1938 when she was 12 and the first year that EIC opened.

In an interview, Erna recalled many wonderful and vivid memories of Eagle Island including attending the dedication ceremony in "this land enchanted for all time" which was attended by Henry and Florence Graves.

She particularly recalled paddling back to Eagle Island in great joy, with the sun shining on the still waters of Racquette Lake, after a challenging five-day canoe trip during which it rained heavily. The group had struggled against strong currents and was forced to shelter overnight in an Adirondack lean-to.

Erna remembers accurately judging wind and waves and picking the winning strategy in a sailboat race.

After graduating with honors from Wellesley College, Erna earned a Ph.D. in logic and foundations of mathematics from Yale that led to a career at Bell

Laboratories in New Jersey. There Dr. Hoover broke three glass ceilings and became the first woman to head a technical department. There she created a computerized switching system for telephone call traffic which earned one of the first software patents ever issued.

In 2008, Erna was elected to the National Inventor's Hall of Fame. Erna said her experiences at Eagle Island gave her and other campers the self-confidence to become leaders in Science, Medicine, Government, Environment, and the Arts. FEI is grateful to count Erna as one of our Friends and loyal Alumnae.
