

## The AI Of The Possible:

Developing Scotland's Artificial Intelligence (AI) Strategy

**Consultation Paper** 



#### Overview

The Scottish Government is committed to developing an Artificial Intelligence (AI) strategy for Scotland, as set out in *Protecting Scotland's Future: the Government's Programme for Scotland* 2019-2020, published in September 2019. The strategy will help ensure that Scotland maximises the potential economic and social benefits of AI, and send a strong signal to the world about our ambition.

The Scottish Government has tasked The Data Lab with convening the strategy development process, overseen by a steering committee chaired by Kate Forbes MSP, Minister for Public Finance and Digital Economy. The committee was established by the Scottish Government and The Data Lab to ensure that there is balanced and diverse representation of all relevant bodies and sectors and from across Scotland.

#### Why Are We Consulting?

In January 2020 the steering committee published the strategy scoping document, which sets out a draft vision for AI in Scotland and a proposed approach to fostering the adoption of AI in Scotland. The steering committee are keen to discuss and address the most important questions necessary to developing an AI strategy that is people-centred and reflects, in its vision and approach to realising the potential of AI in Scotland, peoples' thoughts and priorities on how this can be achieved in a way that ensures no one is left behind.

They would welcome your response to our consultation questions, on the proposed definition of AI for the purposes of the strategy, the draft vision for AI and the proposed approach to fostering the adoption of AI in Scotland outlined in the scoping document. #### **Privacy Notice**

#### Why your information is being requested

The Scottish Government has tasked The Data Lab with convening the process to develop Scotland's Al Strategy. To help inform further work to develop the strategy we would like to hear your views on the proposals set out in the strategy scoping document.

Our lawful basis for processing your personal information is Article 6(1)(e) of the General Data Protection Regulation<sup>1</sup>. We collect and process this data for the performance of a task carried out in the public interest.

#### How will your data be stored?

The Scottish Government and The Data Lab are Joint Data Controllers and will store all the data collected from this consultation confidentially on secure servers. The small amount of personal information collected will be covered by data protection legislation. The Joint Data Controllers will store the data for as long as the information is required for statistical analysis. Access to the data is limited to Scottish Government and The Data Lab staff who require to use it for the purposes described below.

#### How will the information be used?

The information provided in responses to the consultation will be used to refine the vision for and proposed approach to fostering the adoption of AI in Scotland, and inform the next phases of work in the strategy development process.

The Scottish Government and The Data Lab as Joint Data Controllers will have access to your responses and respondent information. Responses and personal contact information will not be published. Names of respondents will only be listed in review publications with respondents' consent.
