I am so thankful to have joined this organization, and I will continue to fight for this cause. I hope my story inspires others to fight in their own communities.

Apply for the People's Maps Commission TODAY!

This is the last week to apply for the People's Maps Commission. The deadline for applications to be received is this **Friday**, **July 31**, **2020**. Applications will be evaluated by a panel of retired judges: Janine Geske, Joseph Troy and Paul Higginbotham. Monthly hearings are set to begin in September 2020 and will run through April 2021. The People's Maps Commission Application Information

Eligibility criteria to join The People's Maps Commission includes that a person:

- Be 18 years of age or older;
- A Wisconsin resident;
- May not be:
 - Registered as a lobbyist in the last 5 years;
 - A declared candidate for a local, state, or federal elected office;
 - A state public official as defined by Wis. Stat. § 19.42(14);
 - A local public official as defined by Wis. Stat. § 19.42(7x);
 - An officer or member of the governing body of a local, state, or national political party.

Applications must be notarized and received by July 31, 2020. Information about how to get a document notarized and how to use a remote notary is <u>available here</u>. Applicants may email their application to <u>PeoplesMaps@wisconsin.gov</u> or mail it to Office of Governor Evers, ATTN: People's Maps Commission Application, PO Box 7863, Madison WI 53707.

Where the People's Maps Commission Fits In

While the Wisconsin Fair Maps Coalition is thrilled that Gov. Evers is moving forward with the People's Maps Commission, we all need to recognize where the Commission fits in with our overall campaign to ban gerrymandering in Wisconsin and to finally get independent, nonpartisan redistricting here.

The People's Maps Commission is a public education and awareness tool. Starting this fall, the Commission will be holding hearings in all eight Congressional districts, getting input from the citizenry about how they'd like to see fair maps drawn. That's a good thing: Transparency and participation are crucial for our democracy. We're hoping you'll be able to attend the hearing in your area.

Once the Census data is handed over to the state, the People's Maps Commission will draw its own maps in an independent and nonpartisan way, so we'll all be able to see what that actually looks like.

But the Commission doesn't have any power. It can't force Speaker Robin Vos and the Legislature to adopt these maps, and Vos has made no secret of his desire to draw the maps his way – the rigged way.

Yes, we'll be able to use the maps drawn by the Commission to illustrate just how far afield from fairness the new Vos maps are.


But we'll still need to pressure everyone in the Legislature not to vote for the rigged Vos maps.

Here are three ways we marshal that pressure:

- --by keep passing fair maps referendums and resolutions in county after county, demonstrating to candidates and elected officials that their constituents feel very strongly about this issue.
- --by urging candidates to pledge not to vote for rigged maps and instead to vote for independent, nonpartisan redistricting like they have in Iowa. And letting voters know where they stand on this issue through letters to the editor and social media.
- --by signing the voter pledge that says we won't vote for any candidate who isn't in favor of changing the law to give us independent, nonpartisan redistricting.

In short, the People's Maps Commission isn't a cureall. But it is part of the massive public organizing effort under way to build sufficient pressure so that whoever is elected to the Legislature, they won't vote for rigged maps.

Instead, they'll do what their constituents want: They'll pass a law that finally bans gerrymandering in Wisconsin.

Gerrymandering Dilutes Voters' Voices

Farmers Union invites rural, urban voters to bridge the divide and fight for fair maps



For the last six years, Wisconsin Farmers Union members at our annual convention have voted to end gerrymandering and replace it with nonpartisan redistricting. WFU is developing voter education materials, organizing at the state and local levels, and collaborating with like-minded organizations to move the dial towards real democracy. Recently, we launched a video, *Fighting for Democracy: Fair Maps in Wisconsin* and held a virtual town hall with over 150 attendees. In turn, those participants have committed to holding candidate and elected official's feet to the fire, getting them to **pledge** their support for nonpartisan redistricting.

Some people wonder why a family farm organization cares about an issue like fair maps. It's because we recognize that no matter one's political persuasion, casting a ballot that counts is as American as it gets. Unfortunately, in the state of Wisconsin, your vote is shaped by the party in power. In 2016, a federal court ruled that Wisconsin voters are disenfranchised; their votes are diluted because of the way the maps have been drawn and this is a constitutional violation.

Gerrymandering fuels partisan politics, enabling elected officials to close their doors and ears to many of their constituents and rest comfortably term after term, knowing their seat is secured. When people lose faith in their ability to petition the government

through voting and their representatives have no incentive to listen, people either disengage from the democratic process or resort to more radical ways to be heard.

Recently, I moved from Menomonie to Chippewa Falls. Like much of Wisconsin, voting district lines here are zig zags and squiggles, not following any sort of natural or recognizable boundary. When I asked my town clerk what assembly district I was in, she wasn't sure either. She had a map in her office to try and help residents, but she couldn't tell me with certainty because of the confounding maps. She noted voters around here are terribly confused, showing up at familiar town halls only to be told that they were in the wrong district. I treasure citizen engagement in the political process. Election maps should organize, clarify and direct citizens to exercise their right to vote and call on their representatives. Instead in Wisconsin they are rigged to confuse, diminish, and manipulate the electorate and protect the party in power.


