Assessment Fee per seminar

If, by the end of the course, you receive one NYC (Not Yet Competent) grade you will not be charged an assessment fee to re-sit that assessment. If you receive two or more NYC grades you will be charged for each assessment you need to resit, subject to prior approval by the National Director. If you have received three or more NYC grades, you may be required to complete the entire course. If this is the case, you will be required to pay another course fee.

Study fee per seminar (if you are required to repeat the seminar)

The following study fees only apply where the National Director has approved you repeating individual seminars. Study fees per seminar do not apply if you have been required by the National Director to repeat the whole course. (Regulation 14, 16 and 17 of the Professional Legal Studies Regulations 2004.) If the National Director requires you to repeat and re-enrol in a seminar you will be charged the following study fee plus the \$60 including GST assessment fee for each assessment to be marked:
