For all meditation classes & appointments cancellations must be made 3 hrs. before the start of your booked session. If a late cancel occurs, you will lose your session & charged the full amount. Members will be charged \$9 per late cancel of a meditation session.

Return Policy

All Sales of products and packages are final sale and no refunds will be given.

Packages that are purchased have 12 months to use all session from the time of purchase before they expire.

Termination of membership by Urban Meditation

In the event of a termination a refund will be given for the balance of the package if purchased. The membership fees will stop immediately upon notice of membership being revoked.

Freeze Policy

You may freeze your membership twice per contractual year. Each freeze period may last for a minimum of one (1) month and maximum of two (2) months.

Term & Cancellation Policy

This is a month to month membership and is automatically drafted each month on the same day as your initial billing date. Automated and electronic payment continue each month until you tell us to stop. You must give a thirty (30) day notice. You may cancel for any reason. However, if you do not give a thirty (30) day notice you will be cancelled the next billing cycle.

In order properly cancel your membership, you must submit a signed cancellation of membership notice to the studio in accordance with the term and conditions of membership. In the event your studio cannot collect payment electronically, you will be notified and payment,

must be made by other means, no later than the 15th day after due date to avoid a cancellation in membership.

All meditation packages are final sale. Full amount of package will be charge up front. No returns or cancellations will be given.

No returns on drop in clients. All charges will be made up front before admittance into the meditation studio.

Membership Fee

By signing below member authorizes us to charge the credit/debit card presented by the member for all charges incurred by the member in association with his/her membership plan, including enrollment dues and monthly recurring charges.

Hours of Operation

From time to time, the studio may partially or fully close and be unavailable for use for reasons including, without limitation, renovation, repair, special events, or holidays. Hours of operation will be displayed in the studio but may be modified from time to time without notice.

Responsibilities & Policies

- 1. Registration for Class: to participate in a meditation class or one on one session you must make a reservation either via mind body app, in person appointment. Booking is on a fist come first serve basis. You can book into a session up to thirty (30) days prior to session date or however far out the schedule permits.
- 2. Eight (8) hour class cancel policy: Urban Meditation enforces a strict 8-hour cancellation policy and late cancellations and no shows will lose their payed session. If unlimited membership, they will be charged a \$5 no show/late cancel fee to the card on file with Urban Meditation.
- 3. Class Tardiness: timely attendance for classes are mandatory. If you arrive to your class after the scheduled start time you will forfeit, your reservation in that session to another member on a waitlist. We encourage you to arrive at least 10 minutes early to reserve your space in the studio & relax & prepare for meditation.
- 4. There are no cell phones permitted inside of the meditation studio. Lockers are providers for cell phones and personal belongs.
- 5. Crystals not purchased from Urban Meditation are not permitted inside the studio unless personally cleansed by Urban Mediation and cleared for admittance
- 6. Once mediation has started no speaking or talking in studio
- 7.
