## **NETWORKING**

Since its inception, Pastors for Florida Children (PFFC) has networked with the statewide faith community to invite clergy and laity to participate more fully in the legislative process by advocating for the passing of bills that support teachers and students in the public education system and opposing legislation that is harmful to public schools and diverts funding away from an underfunded system of public education. During the 2021 Florida Legislative Session, PFFC networked with the leadership and members of the following nine denominations: 11th District of the African Methodist Episcopal Church, Christian Methodist Episcopal Church, Church of God, Cooperative Baptist Fellowship of FL, Evangelical Lutheran Church in America, Florida Conference of the United Methodist Church, Pentecostal Assemblies of the World, Presbyterian Church (USA) South Atlantic Synod, and Progressive Baptist Missionary & Education Convention.
