NEW MEXICO BRED QH & TB YEARLING SALE: TB AUGUST 9...QH AUGUST 9 & 10

The sale will commence approx. I hour each day after completion of the All American Futurity Trials. Entry fee is **\$650** for both breeds. Entry and Withdrawal deadline is **May 1**.

SELECT QUARTER HORSE YEARLING SALE - AUGUST 30, 31 & SEPTEMBER 1

This sale is for Quarter Horse yearlings that have been selected by a review committee based on conformation and pedigree. All entries must be eligible for the 2025 Triple Crown. The consignment fee is **\$650**. All fees are refundable for entries not accepted for the Sale. Entry and Withdrawal deadline is **May 15.**

The following information applies to all sales:

<u>WITHDRAWALS:</u> The withdrawal deadline is May 1 for the NM Bred Sale and May 15 for the Select Sale. The entire entry fee is due if withdrawn after the deadline. Under the circumstance of death or illness, a maximum refund of \$200 *may* be considered upon receipt of a veterinarian's letter of explanation. No refund for *any* reason will be approved after the entries have gone to catalog.

<u>FEES</u>: **NMBred & Select Yearling Sales**: If fees are to be withheld from proceeds, they are increased by \$100 to **\$750**, and the Certificate of Registration must accompany the consignment at time of entry.

<u>DOCUMENTS</u> <u>DUE AT TIME OF ENTRY-</u> consignment acceptance contingent upon receipt of all required documents by withdrawal deadline.

Consignment Form: The owner/agent information as shown on line one of the catalog is taken exactly from the "Consigned By" line of this form.

Completion of "<u>To Receive Proceeds</u>" portion is mandatory. If funds are to be disbursed to other than the registered owner, a letter of authorization from said owner must accompany the consignment documents. Checks will be mailed to the indicated address.

<u>Certificate Of Registration</u>— all New Mexico Bred entries must have the NMHB Accreditation number stamped on papers <u>at entry</u>. Select entry's Certificates Of Registration must be included at entry. All horses are inspected by the Sale Co. If the Registration Certificate description doesn't agree with the actual markings, an AQHA Corrected Certificate form, four photographs, and appropriate fees must be sent to AQHA for reissuance of an accurate Certificate. Cost to seller: **\$95.00**. All Certificates must be *Parentage Verified*. Check your Registration Certificate for accuracy!

AQHA Transfer Report on all Quarter Horses. Additional copies available online from AQHA or Sale Company's Website.

HIP NUMBERING: Consignors may flip pairs of numbers of any entries under the same ownership. Changes will be accepted by written notification only (Emails are acceptable) within 5 days of notification. **No Exceptions!**

NM BRED SALE: Hip numbers will be drawn at random by Sales Office personnel on June 3.

SELECT SALE: Hip numbers will be drawn at random by Sales Office personnel on July 1.

STALL ASSIGNMENTS: Stall assignments will be finalized approximately two weeks prior to each sale. Special stall requests if received 6 weeks prior to sale are considered, but not guaranteed Each stall will be adequately bedded once by the Sale Co. After arrival it is the responsibility of the consignor to rebed.

STALL CARDS: Stall cards will be provided at no charge and will be installed by the Sale crew. Please notify the Sales office if you will provide your own cards.

ENGAGEMENTS: Sustaining payments for the Triple Crown will be verified through the last payment date only; supplements after the June 15 payment must be reported immediately in order to be included in the Catalog. No other engagements provided by owner are verified by Sale Co.

<u>UPDATES & RESERVES:</u> ALL UPDATES AND RESERVES MUST BE IN WRITING. (Forms are available in the Sale office and on our Website.)
Updates to be included in the catalog must be in the Sale office by June 20 for the NMBred sales and by July 13 for the Select Sale. After that date, Updates will be announced at the Sale. All Reserves have to be handled in person in the office prior to the Sale. Last-minute Updates and Reserve requests will be accepted by Sale office personnel only, no later than 2 hours prior to the Sale.

CATALOGS: proof pages are available upon request from QData Custom Catalogs (405-262-3244). Proofing is the consignor's responsibility. Catalogs will be mailed approximately 2-3 weeks prior to each Sale; to receive mailed catalogs, request must be made 30 days prior to Sale. Otherwise catalogs are available at the Sale and online from website.

LIVESTOCK INSPECTION: The New Mexico Livestock Board requires an entry permit for all out-of-state livestock entering New Mexico. The NMLB issues the permit by phone (800-432-6889). The Board also requires a brand inspection for livestock traveling within the State.
