PHOTOGRAPHER FEE PAYMENT

A **\$75.00** photographer fee is required per family brought to the farm by a professional or amateur photographer. A "family" is defined as a group of one or more persons that are participating in the same photo shoot. A "professional" or "amateur" photographer is defined as one who shoots photos with the intent of delivering them to a client or friend/family member, whether for profit or not. We accept cash or credit card on the day of your appointment. Checks are not accepted. No deposit is required. No payments will be accepted prior to the day of your appointment. Paying the photographer fee does not guarantee that you will have the property to yourself. Appointments are scheduled during normal business hours only.

OCTOBER APPOINTMENTS: The photographer and their clients are not required to pay the public entrance fee.

AVAILABLE APPOINTMENT DATES

The only appointments available are those listed on the [online form](#). No additional dates will be added throughout the season. We do not offer any advanced dates for free promotional shoots.

CANCELLATIONS AND RESCHEDULING

There is no penalty for cancellations or no-shows. If you would like to reschedule, please submit a new request form at www.oldtimechristmastree.com/photographerappointment. There is no need to notify us about a canceled or rescheduled appointment.

CHECK-IN

OCTOBER APPOINTMENTS: The photographer must check in at the front entrance tent cashier.

NOVEMBER/DECEMBER APPOINTMENTS: The photographer must check in at the red cashier building.

The photographer will sign the Photographer Agreement and submit payment to the cashier. Photographer must provide a valid Photo ID in exchange for an official photographer lanyard. Cashier will keep your ID on file during the duration of your shoot. Please meet your clients near the front entrance. The Old Time Christmas Tree Farm is not responsible for locating you or your clients at any time. Upon exiting, please return the photographer lanyard to the cashier and pick up your photo ID.

WHERE YOU CAN SHOOT

Keep out of homes, backyards, buildings, bodies of water, and areas posted "no trespassing". Please do not interfere with customers.

OCTOBER APPOINTMENTS: Photographers and clients may travel by foot to the Pumpkin Patch and Christmas tree fields. Please do not travel past the signs marked "no pedestrians past this point".

NOVEMBER/DECEMBER APPOINTMENTS: Photographers and clients may travel by foot to the Christmas tree fields.

PROPS

All props must be small enough to carry in from the parking lot. Vehicles are not permitted to drive onto the property to drop off props. The use of furniture or prop rental services is not allowed.

PROHIBITED ITEMS

No alcohol, glitter, confetti, or outside food or drinks will be allowed in. No boudoir photography sessions will be allowed. Please be respectful of our farm and refrain from littering.

PETS

Well behaved pets are allowed and must be kept on a leash at all times. Please clean up after your pet.

CAUTION

Be aware of ants, tree stumps, live animals, moving vehicles, and other environmental hazards. The Old Time Christmas Tree Farm is not responsible for any injuries sustained or lost, stolen, or damaged items.
