Purpose and Methodology

The purpose of this report is to provide information about the Arab population in Canada. The data presented in this report has been collected from the <u>Statistics Canada 2016</u> <u>Census of Population Program</u> data, with a focus on the <u>Immigration and Ethno-cultural Diversity</u> topic in order to understand the distribution and demographics of the Arab population in Canada. This report examines the Arab population from various perspectives, including, but not limited to, age, gender, education, fields of study, and labour force.

Where Arab ethnic origin data was available, data relating to the 22 member states of the Arab League (or as many as available) was collected and used. The 22 members of the Arab League are Algeria, Bahrain, Comoros, Djibouti, Egypt, Iraq, Jordan, Kuwait, Lebanon, Libya, Mauritania, Morocco, Oman, Palestine, Qatar, Saudi Arabia, Somalia, Sudan, Syria, Tunisia, the United Arab Emirates, and Yemen. It is important to note that ethnic origin responses in the census are a reflection of each respondent's perception of their ethnic ancestry.

The total ethnic origin response counts (which are presented in this report) indicate the number of persons who reported a specified ethnic origin, either as their only ethnic origin or in addition to one or more other ethnic origins. Therefore, total ethnic origin responses are the sum of single and multiple responses for each ethnic origin. The sum of the ethnic groups in the Statistics Canada data is greater than the total population estimate because a person may report more than one ethnic origin in the census.¹

In some instances, data related to Arabs was collected from products that included "Arab" as a visible minority. According to Statistics Canada, visible minority refers to whether a person belongs to a visible minority group as defined by the *Employment Equity Act* and, if so, the visible minority group to which the person belongs. The *Employment Equity Act* defines visible minorities as 'persons, other than Aboriginal peoples, who are non-Caucasian in race or non-white in colour'. As such, and in accordance with the employment equity requirements, if a person

reported being 'Arab' and 'White', they would have been excluded from the Arab visible minority population. Also, if a person reported being 'Arab' and provided a European write-in response such as 'French', they would have been excluded from the Arab visible minority population as well². The exclusion of some Arabs from the Arab visible minority population count significantly reduces the number of individuals in the Arab visible minority population.

The data presented in this report is accompanied by footnotes to clarify whether the data has been collected using Arab ethnic origins or if it's based on the Arab visible minority population count.

Disclaimer: A previous version of this report incorrectly included data on "Mauritian" ethnic origin. As a result, the data that included "Mauritian" ethnic origin has been corrected and updated.

Summary of Key Findings

- There are a total of 947820 people in Canada who reported having an Arab ethnic origin based on the 2016 Census data, with slightly more males than females (51.6 % males and 48.4% females).
- The very large majority of the Arab population (>90%) in Canada resides in Quebec, Ontario and Alberta.
- People of Lebanese, Moroccan, and Egyptian origin have the highest numbers among the Arab population in Canada.
- The majority of the Arab population in Canada resides in three metropolitan areas: Montreal, Toronto, and Ottawa-Gatineau.
- The majority of the Arabs in these metropolitan areas are of Moroccan, Lebanese, Algerian, and Egyptian origin.
- Almost 30% of people in the Arab population in Canada are under the age of 15.
- More than half of the individuals living in Canada who were born in an Arab country were admitted into Canada as economic immigrants; almost a quarter of the individuals living in

Canada who were born in an Arab country were admitted into Canada as refugees.

- There are some citizenship status variation depending on the Arab place of birth.
- More than 60% of the Arab population in Canada are first generation.
- A total of 629055 people in Canada have knowledge of the Arabic language.
- More than 60% of the Arab population in Canada

has some type of postsecondary certificate, diploma or degree.

- Business, engineering, and health professions are among the top fields of study for the Arab population in Canada.
- Of the total number of Arabs in Canada with a labour force status, the unemployment rate is ~13.5%; this trend is observed in Canada as a whole as well as in the top 3 provinces where the Arab population in Canada resides.

The Arab Population in Canada

The table below shows the distribution and gender of the Arab population in Canada as a whole, as well as in each of the provinces and territories. Based on the 2016 Census, there is a total of 947820 persons in Canada who reported having an Arab ethnic origin 3 , with more than 90% of the Arab population residing in Quebec, Ontario, and Alberta. The Arab population in Canada has increased by \sim 34% since the 2011 Census and by \sim 75% since the 2006 Census.












Arab Population⁷ in Metropolitan Areas

The graph below shows the top metropolitan areas where there is a high concentration of Arabs. The majority (65%) of the Arab population in Canada resides in Montreal, Toronto, and Ottawa-Gatineau.

In the most Arab-populated metropolitan areas in Canada, the vast majority of Arabs found are of Moroccan, Lebanese, Algerian, and Egyptian origin.



Top Federal Electoral Districts⁸ with the Highest Arab Population⁹



The graph below shows the distribution of the Arab population's age groups in Canada as a whole. Almost 30% of the Arab population in Canada is under the age of 15.




Arab Place of Birth and Immigration Admission Category

The table and chart below show the immigration admission category of those living in Canada with an Arab place of birth. Of the people living in Canada and born in an Arab country, more than half have been admitted into Canada as economic immigrants. Further, almost 25% of people living in Canada who have an Arab place of birth have been admitted into Canada as refugees.




Arab Place of Birth and Citizenship Status

The table below shows the citizenship status of individuals who were born in an Arab place of birth. Of note, the very large majority of individuals born in Lebanon are Canadian citizens. In contrast, less than half of individuals born in Syria are Canadian citizens. This may be due to the recent influx of Syrian refugees.


Select Places of Birth and Citizenship Status

Labour Force

In comparison to the other visible minority groups in Canada, the Arab population¹⁸ has a lower employment rate and a higher unemployment rate. This trend is observed in Canada as a whole, as well as in the three provinces with the highest proportion of Arabs.
