Purchase of a Membership is an agreement of acceptance to our policies.
- Membership fees are payable to the Bowen Island Golf Club. Online payment via credit card is preferred. **BEFORE PROCESSING A SALE EACH MEMBER NEEDS TO REGISTER WITH THEIR OWN EMAIL ADDRESS.**
- 2022 Membership begins on January 1, 2022, and concludes on December 31, 2022. Appropriate Green Fees will be charged as of February 1st if membership has not been paid.

## REGULAR MEMBER - FULL PLAY

- Initiation Fee: Nil
- Yearly Membership Fees: \$1625 plus GST
- Voting Privileges: One (1) vote per member

## REGULAR MEMBER - SPOUSE FULL PLAY

- Initiation Fee: Nil
- Yearly Membership Fees: \$900 plus GST  
Spouse/partner must reside in the same household as Regular Member
- Voting Privileges: One (1) vote per member

## INTERMEDIATE MEMBER - 30-45 YEARS

- Initiation Fee: Nil
- Yearly Membership Fees: \$1000 plus GST
- Voting Privileges: One (1) vote per member

## INTERMEDIATE MEMBER - 19-29 YEARS

- Initiation Fee: Nil
- Yearly Membership Fees: \$700 plus GST
- Voting Privileges: One (1) vote per member

## JUNIOR MEMBER - 18 YEARS & UNDER ALL JUNIORS PLAY FREE!

- Initiation Fee: Nil
- Yearly Membership Fees: \$0
- Voting Privileges: None

## LIMITED PLAY MEMBER - 20 ROUNDS

- Initiation Fee: Nil
- Membership Fees: \$700
- Voting Privileges: One (1) vote per member

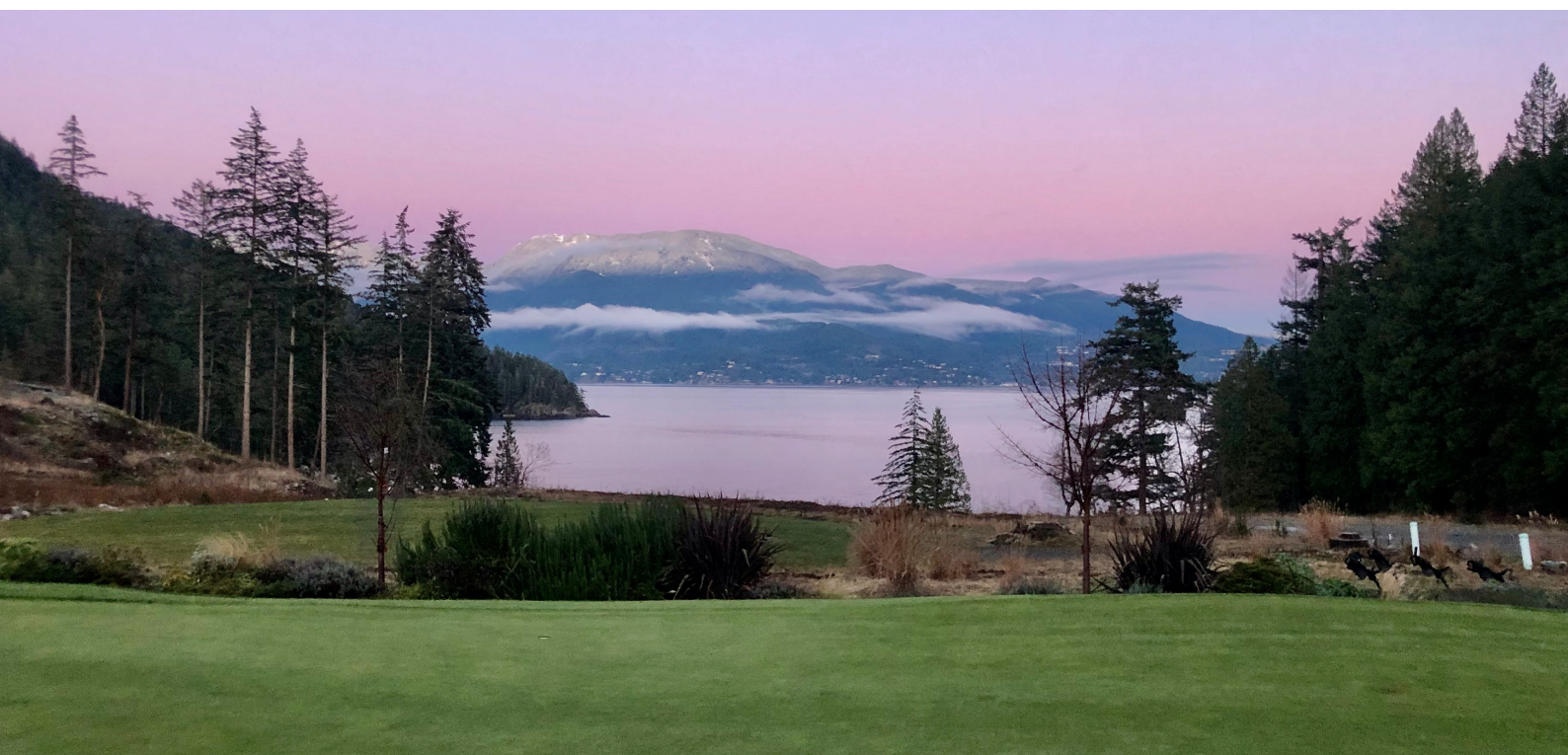


# General Terms:

- All full play members are entitled to unrestricted play for the full calendar year, entry into all member-only events, 15% discount on all regular priced merchandise, and power cart purchases.
- Membership allows a 10 day in advance booking for tee times.
- Junior Golf Tee times are restricted to play after 12:00 pm on all days. For morning play, regular green fees will apply. All juniors 12 and under require adult (19+) supervision during their round.
- The age determination for Junior and Intermediate Members will be based on their age at January 1st of the calendar year for which Membership Fees are being paid.
- Quarterly payments are available for Regular/Spouse members only, a surcharge will be added. Please speak to the Proshop staff or email [membership@bowengolf.com](mailto:membership@bowengolf.com) to make arrangements.

# BOWEN ISLAND GOLF CLUB POLICIES



At any point during the golf season, if a member does not uphold BIGC policies, the member will be subject to disciplinary action. The member will first receive a written warning from management. Should the infractions persist, the member will receive a 2nd written warning, and in the event, the member still does not adjust their behavior accordingly, BIGC will issue a letter terminating their membership. The member will receive a prorated refund of their dues. BIGC will adhere to a strict procedure in such matters.

Operating Hours are set by the Board of Directors and may change from time to time. BIGC facilities may be closed to the public and members on specific days throughout the season due to weather, maintenance, and/or use for private functions.

All annual packages purchased are valid for the 2022 season only. For any reason, annual memberships cannot be used please contact management to discuss options.

In the event of inclement weather (including lightning), it is the golfer's responsibility to find safe shelter or continue to play at their own risk.

## **Policies:**

- **Tee Times:** All golfers must book their tee times through the golf shop or online and must check-in prior to their scheduled tee time. All golfers are required to cancel unneeded tee times. Failure to cancel prior to the scheduled time will result in a written warning.
- **Alcohol:** BIGC conforms with all regulations set by the British Columbia Liquor and Cannabis Regulation Branch regarding the sale of alcoholic beverages. All golfers and guests are prohibited from bringing their own outside alcohol onto the property. All alcohol consumed on BIGC premises must be purchased at the Club. BIGC will refuse the sale of alcoholic beverages to patrons who appear intoxicated.
- **Golf Carts:** No more than two(2) passengers in a golf cart, follow appropriate cart path restrictions, the golfer is responsible for any damage to the cart during their usage of a cart.
