Gifts for Seniors, which has been dedicated to enhancing the well-being of isolated older adults since 1994 and serves over 7,000 annually. Our partnership with Gifts for Seniors amplifies their outreach by connecting them with a network of resources, philanthropic donations, and volunteerism. Through our Corporate Projects program, they've tapped into a pool of dedicated volunteers, including corporate partners who contribute to high-impact projects, such as making gift packs and senior care packages.

In addition to volunteer support, HandsOn Twin Cities has provided capacity-building assistance through our Pro Bono Advisory Program, which has been instrumental for Gifts for Seniors as they continue to grow. By participating in initiatives like our Connected for Change Days, most recently in this year's HR Day, Gifts for Seniors has been able to improve board recruitment and effectiveness, furthering their mission.




