LATOIYA'S STORY

MIDTOWN HELPS LATOIYA BOOST HER CONFIDENCE AND BUILD HER INDEPENDENCE

As a child, Latoiya spent her afternoons in Midtown's Youth Development program, taking part in cooking classes, sports, and arts and crafts.

"It was always such a kid-friendly place," she said. "What I remember were all the smiles and fun - there was just this positive energy all around us. You always felt safe and happy when you were there."

When she became more involved with school activities in high school, she thought her days at Midtown were behind her. That was until she had children of her own and discovered Family PRIDE through her sisters who were active participants in the parenting program.



Latoiya joined Midtown at a picnic one day and immediately rediscovered her love for the organization and community. And for Latoiya, this reconnection couldn't have come at a more critical time. Pregnant and undergoing treatment for cancer, Latoiya found the resources she needed to handle the challenges in front of her.

"I felt like I was losing everything around me, but Midtown was there for me. The staff was always asking, 'How can we help you? What can we do to make life easier for you?' There were days I was too sick to move, but Midtown was at my house dropping off diapers or calling me to check in."

In addition, the access to free therapy, connections to services, and the support of her fellow Family PRIDE moms played a role in her healing. Now that she is healthy and in remission, Latoiya, a talented makeup artist, has dedicated herself to growing her clientele in 2022. Through Midtown's financial planning workshops, she has learned best practices for investing in her business and building her savings to provide a solid foundation for herself and her four children.

"You can always depend on Midtown for anything you need, whether it's diapers, gas cards or just someone to talk to. They really take a load off your shoulders financially and emotionally. But more important, Midtown helps you focus on your growth. They are here to set us up to be stronger women, stronger mothers and stronger people. I know they've helped me find faith in myself."

2021 PROGRAM HIGHLIGHTS



FAMILY PRIDE

In 2021, Family PRIDE led 55 online workshops for 50 parents that covered everything from safe sleep and yoga to financial planning and processing life transitions. In addition, our moms continued to receive culturally responsive therapy with Thoughts Out Loud Counseling, and moms-to-be had access to free doula services from Deeply Rooted Birth & Wellness that empowered them to advocate for themselves and their newborns.



YOUTH DEVELOPMENT

This summer, we were finally able to safely welcome our kids back to Midtown! During our 32nd annual Summer Academy Day Camp, 80 campers participated in cooking classes, arts and crafts activities, and field trips as well as led a Peace Parade. Since September, our afterschool program has provided 50 students with free tutoring, homework help and STEAM classes. We also expanded our Teen Club offerings in 2021 to help high school students prepare for college and their future careers.



ADULT PROGRAMMING

Because loneliness is one of the biggest threats to a senior's overall health, we ensured our Midtown Mamas and Men's Club stayed connected to Midtown and each other by providing them with free tablets and WiFi. Throughout the year, the Midtown Mamas participated in 93 virtual exercise classes, financial planning, computer and health workshops, and arts and cooking activities. In October, we were finally able to get together for an outdoor picnic!



CITY GREENS COMMUNITY GARDEN

While City Greens continues to offer our neighbors in need fresh fruits and vegetables, it also transformed into an outdoor classroom for our Youth Development program to demonstrate the importance of healthy eating. As part of afterschool and summer camp, the kids planted and harvested a variety of produce that they transformed into homemade onion rings, French fries, hand pies, and other homemade goodies.


