Since its inception in 2016, Encircle has deployed two core initiatives to provide ongoing support to vulnerable LGBTQ+ youth and their families: 1) A suite of evidence-based affirming programs designed to cultivate connection, family acceptance, and belonging, including daily peer-to-peer Friendship Circles; 2) Access to co-located quality mental health therapy services. Since opening its first home in Provo, Utah in February 2017, Encircle has provided life-affirming programming to over 108,593 LGBTQ+ individuals, including 10,917 subsidized mental health therapy sessions; and 3) Publishing educational materials and Community Engagement.

Encircle Therapy encourages LGBTQ+ youth to seek help by subsidizing ten sessions of mental health therapy with a licensed therapist to any youth who seeks it. For those without mental health insurance or stable financial resources, Encircle offers a sliding-scale fee structure to attempt to bridge the gap between socioeconomic status and access to mental health services. Encircle Therapy is currently paneled with nine health insurers.
