Encircle has continued three core initiatives to provide ongoing support to vulnerable LGBTQ+ youth and their families: 1) A suite of evidence-based affirming programs designed to cultivate connection, family acceptance, and belonging, including daily identity and aged based peer-to-peer support groups; 2) Access to co-located quality mental health therapy services online and in person; 3) Publishing educational materials and Community Engagement.

In 2022, Encircle provided 66,303 services, including 4,622 therapy sessions, 9,659 support group visits, and 2,657 parent program visits.
