

Unit 3 was traveling south on SR 79 in the left lane. Unit 3 stopped behind Unit 2. The light turned green and Unit 1 and Unit 2 did not move because of traffic. Unit 3 moved forward and struck the rear of Unit 2 causing it to be pushed forward into the rear of Unit 1.






