
**NARRATIVE**

On August 23, 2020 I was dispatched to S. 30th and SR. 79 on a report of a non injury accident. Dispatch said a white colored Chevy sedan and a silver Kia Soneto were involved. I was able to locate the vehicles in the parking lot of Olive Garden. After speaking with both driver's I was able to determine what happened and who was at fault.

Unit 1 said he was traveling south on 30th street near Lowe's when another vehicle had merged over into his lane of travel and struck his front driver's side bumper.

Unit 2 stated she was also traveling on S. 30th and needed to get into the far right turn lane so she could pull into Olive Garden. Unit 2 committed to the lane change but did not see another vehicle was already traveling in that lane. Unit 2 then struck the Chevy sedan with her passenger side rear quarter panel. No injuries were reported at the time of this crash.




