
NARRATIVE

On July 24, 2020 I was dispatched to Parkview Dr and SR. 79 on a report of a non injury crash. After speaking with both driver's I was able to determined what occurred.

Unit 1 said he had stopped for a red light while in the left turn lane to enter SR. 79. When the light turned to green he started moving forward then heard a loud crunch. Unit 1 looked back and observed a small 4's sedan with front bumper damage. No damage was visible on Unit 1's truck.

Unit 2 stated he was attempting to get over into the left lane as well to get onto SR. 79. Unit 2 thought Unit 1 had slowed down enough so he could merge over. Unit 2 then struck Unit 1 with his front driver-side bumper. Front bumper damage was visible. No injuries were reported.
