
NARRATIVE

On September 28, 2020 I was dispatched to Irvingwick Dr W and Heath Rd on a report of a non injury crash. A green Honda Civic and a white Subaru station wagon were involved. After speaking with both driver's I was able to determine what happened and who is at fault.

Unit 1 said he was traveling east on Irvingwick Dr near Heath Rd. Unit 1 then stated that he observed a large chunk of wood in the road and slowed down to a stop on Irvingwick Dr. Right after Unit 1 was rear ended by Unit 2.

Unit 2 said he was also traveling east on Irvingwick Dr. Unit 2 said he also observed the car quickly slow down for a stop but he could not get his vehicle to stop in time. Unit 2 struck Unit 1 with his front bumper. No injuries were reported.
