JOHN BRANIGIN

Why are you running for Tybee City Council/Mayor?	I was asked to run by numerous residents and friends who feel my approach of collaboration and compromise would benefit our City government.
What do you believe is the role of City Council/Mayor in our community?	The job of the Mayor and Council, collectively, is to set policy. It's that simple. Policies set by the Mayor and Council are then enacted by the City Manager and staff.
What is your vision for Tybee Island? What does Tybee "look and feel like" 10 years from now?	My vision doesn't really matter. I hope Tybee residents can come together and coalesce on a unified vision for the Island. Right now, most "visions" are too focused on one issue or another without taking into consideration a bigger picture.
Name one thing you want to do during your term if elected and describe why accomplishing this is your top priority.	I will continue to push (as I did when I served before) to find a way for the City to become "water independent". Tybee's water permit is insignificant when compared to the total "draw" allowed from the aquifer. Therefore, whatever we do will have little to no impact on the issue of saltwater intrusion. As a result, it is incumbent on us to be prepared for when that ultimately happens. Soulutions are expensive but will only get more expensive the longer we wait.
How would you balance the benefits and impact of tourism and quality of life for residents?	I believe there are more benefits than negatives from tourism on our community and I'm not talking about tourist dollars or tax revenues. Tybee has always been a vacation destination. Our visitors help keep our community infused with a sense of "youthfulness" and fun. Who hasn't felt good after meeting and talking to someone visiting who can't stop talking about what a "great place" this is and how lucky we are to live here. For those few who come here and cause trouble, I believe we have adequate ordinances to manage their bad behavior.
What is your approach to handling complicated and controversial issues?	I believe that collaboration, cooperation and compromise are the keys to dealing with complicated and/or controversial issues.
Describe how you would work with city staff and your view of the ideal relationship between elected council members, mayor, and professional staff.	The City operates under a "City Manager" form of government. By definition, this means that the relationship between elected officials (Mayor and Council) and City staff is largely "hands off". Elected officials mostly interact with the City Manager as only the City Manager may give direction to staff. It may be appropriate for elected officials to "meet" with staff but never in a manner that gives the appearance of giving direction to staff.
What is your view about elected officials who change their mind when presented with facts that are new or that they did not previously know?	Elected officials (and residents) should always be open to broadening their understanding of issues and not be closed minded when presented with new or updated information.
What skills and experience do you have that you believe would be beneficial to our community if you are elected to serve?	I have previously served as the following: Councilman (2018-2021) Council liaison to Public Safety & Finance Committees (2020-2021) Chairman, Audit Committee (2014-2015)

Why are you running for Tybee City Council/Mayor?	Tybee is my home, I raised my children and now my grandchildren I care about the future of Tybee and would like to keep it as a neighborhood for residents and still welcome visitors without hurting our small town feel.
What do you believe is the role of City Council/Mayor in our community?	City council members are supposed to listen to residents and to match make rules, while the city manager and staff make the day to day operations happen based on those rules
What is your vision for Tybee Island? What does Tybee "look and feel like" 10 years from now?	To keep Tybee a small town feeling where businesses can do good and visitors are welcome to enjoy the beach. What Tybee looks and feels like in 10 years depends on the people who are elected and what they do. If they make the rules that are good for residents and make sure infrastructure and public safety is planned right and the beach is taken care of, it will be a good look and feel. Name one thing you want to do during your term if elected and describe why accomplishing this is your top priority.	Work on getting fire safety building started and finished. Public Safety is top priority and we have made good progress on police department and need to do the same for fire and rescue.
How would you balance the benefits and impact of tourism and quality of life for residents?	Work to keep tourism from spreading and overtaking the residential neighborhoods. Regulating the STVRs and businesses like parking lots needs more attention. I have fought for these and will continue if reelected.
What is your approach to handling complicated and controversial issues?	Face them head on, and try to listen to opinions and ideas to try ot find solutions. You can't please everybody, but working with other councilmembers and citizens and businesses and city staff is the best way to try.
Describe how you would work with city staff and your view of the ideal relationship between elected council members, mayor, and professional staff.	I will work with council members to make rules and work with the city manager directly so that the city manager can with employees.
What is your view about elected officials who change their mind when presented with facts that are new or that they did not previously know?	Council members are supposed to look at all the information they have before making decisions. Sometimes information is given to council at the meeting and that could make them change their mind.
What skills and experience do you have that you believe would be beneficial to our community if you are elected to serve?	Listening to residents and using my past knowledge of Tybee's history and my experience of serving on the planning commission and 14 years on council.

JAY BURKE

Why are you running for Tybee City Council/Mayor? What do you believe is the role of City Council/Mayor in our community?	I have several reasons for running for re-election to Tybee Island City Council. One is to continue to carry on the long family tradition of serving our lovely island community. As volunteer fire chief for many years, my grandfather began our family history on the island, followed by my father who served on the city council and dedicated his life to this beautiful island that he so loved. My second reason for running is that I too, was born with sand in my shoes, the only candidate born and raised on Tybee and my goal is to make it the best place in the world to live. My long history on the island helps me to accomplish this goal because I understand the community, it's problems and it's changing needs in ways that those who are newer to the island cannot. The role of a city council is to act as a good steward for the community.
What is your vision for Tybee Island? What does Tybee "look and feel like" 10 years from now?	My vision for Tybee Island is to make this island the best community for its citizens to live and work. Specifically I believe height limits should remain at 35' and with growth expansion moving west towards Lazzaretto Creek, I see a possible need for increased recreational facilities and a new community center.
Name one thing you want to do during your term if elected and describe why accomplishing this is your top priority.	Our Tybee city budget increases every year! If re-elected to the city council, my first priority will be to look at this overall budget and find ways to make our government more efficient by providing better services at lower costs.
How would you balance the benefits and impact of tourism and quality of life for residents?	Balancing the benefits and impact of tourism with the quality of life for our residents is always a difficult task. I feel, however, that this can best be accomplished by enforcing our laws equally for both our visitors and our residents alike.
What is your approach to handling complicated and controversial issues?	When dealing with complicated and controversial issues I try and gather information from both sides to get a clear idea of what's going on. Then I try and evaluate this information fairly in an attempt to find a compromise that provides a positive outcome for everyone involved.
Describe how you would work with city staff and your view of the ideal relationship between elected council members, mayor, and professional staff.	In the past four years as council member, I feel that I've maintained a good rapport with other members as well as those employed by the city. I've done this by maintaining open and honest communication to insure that we're always on the same page on important issues even if our views on how to solve these issues may differ.
What is your view about elected officials who change their mind when presented with facts that are new or that they did not previously know?	In assessing information on how best to provide services to our community and its citizens, new facts are always welcomed. No one is perfect and often in the face of new information, I'm happy to correct my error in judgement and change my vote on any issue.
What skills and experience do you have that you believe would be beneficial to our community if you are elected to serve?	I have always felt it important to be a part of community activities. In the past I've served as chairman of the Tybee Island Planning Commission. Currently I'm liaison to the City of Tyee Business/MainStreet. I've served on numerous nonprofit boards in Savannah and Tybee Island. What do you believe is the role of City Council/Mayor in our community?	To represent the best interests the community and the residents who elected them. It's best if we can work together and not against each other, but obviously there will be disagreements. As long as we remain respectful and professional with each other though, we can work through anything.
What is your view about elected officials who change their mind when presented with facts that are new or that they did not previously know?	My goodness, that's the whole idea. Things change all the time, and so must we. I think much less of someone who wouldn't change. I don't pretend to know everything, and nobody should. We are looking after and maintaining our waterways, marshes and beaches; providing more services of Police, Fire, EMS, upgrading infrastructure for our residents, making efforts to make the island more family friendly, trying to help our businesses succeed, looking after the appearance of our community, historical preservation efforts and providing access to a beautiful beach for all to come and enjoy.
	Tybee is a community that helps others when they are of need. The food bank, churches support, go fund me cancer drives. I look for us to be an even more supportive community with positive attitudes – a large part of leadership is setting a tone and an example.
	A balance of residents and tourists is high on our list on what our focus for Tybee is over the next 10 years.
	The 2024 Annual Budget, adopted on June 22, 2023, page 7 showed that we are projected to spend approximately \$7M in 2024 and \$9M in each of 2025, 2026 & 2027 on water and sewer infrastructure repairs and improvements over the next several years that we were getting behind on. I believe these are all warranted, needed expenses and good for our island to catch up on these infrastructure needs, but these are large numbers to be aware of!
	I see technology continuing to aid our city. In 10 years time, we could be evaluating how to have free wifi access.
	The 2021-2026 Comprehensive Plan denotes 52.4% of our residents are 60 years of age and older. 74.5% of our residents were born before 1980.
	The city is studying how to provide more for families to encourage them to move here including as an example of the questionnaire partnered with YMCA to understand childcare needs on the island.
	With the aging population, we will need to be more aware of our needs in mobility and health care.

Name one thing you want to do during your term if elected and describe why accomplishing this is your top priority.	I am looking for the City of Tybee to be more strategic planning in our efforts. It appears to me that we have been more reactive to situations after they happen. I am looking for us to be more pro-active. I believe a City Operations Manual, developed by the city staff that includes job descriptions, duties and responsibilities, expectations of the positions, 360 degree employee review process including employees ability to review their management, hiring practices, employee rights, training processes, how our city coordinates with the City of Savannah, Chatham County, State of GA and Federal agencies is one of those ways that we become more strategic and pro-active. The City operations manual would contain department procedures in how they conduct their daily operations. It could include public relations expectations, what and how we share public information.
	information guides on the Tybee website that does include some of this information already and a portion of these items may exist or be in work that I could not find. This operations manual will aid us in being more pro-active defining strategic planning expectations than being reactive to conditions after they happen. This operation manual can define preparation for events planned and unplanned on Tybee. Estimation for crowd size can occur 4-6 weeks in advance, staffing of police, fire, ems can be defined for the crowd size and coordination for additional assistance and support a month in advance as a regular activity.
	Written hazard response plans could include plans of temporary water transportation of people if Bull River or Lazaretto Creek bridge were damaged during a hurricane or a ferry system capable of transporting emergency, resident or restoration vehicles.
How would you balance the benefits and impact of tourism and quality of life for residents?	Tourism is the main engine for Tybee economy. This tourism has enhanced the quality of life for Tybee residents including employment opportunities, standard of living, community services, infrastructure, restaurants and introduction of many different cultures of visitors. Per our 2023 approved City of Tybee Budget, of our 17.7M projected 2023 revenue for the general fund; tourism helps bring in directly \$400K STR licenses, \$6.4M projected Hotel/motel taxes including STR taxes, \$5.9M parking revenue plus indirect income of taxes paid on food and services. Assuming most of the \$952K of fines are not coming from our citizens. Assuming more than ½ of the \$2M property taxes are not coming from residents. By my math, those direct accountable income from tourism accounts for approximately \$14.6M of our \$17.7M projected general fund revenue, 82.5% of our budgeted general fund revenue. It has been less than a decade when several businesses would close for the winter months. It is nice to have thriving restaurants and businesses on the island.
	There is an impact to resident quality of life though. Traffic, parking, noise, pollution, impact on infrastructure, not having full time neighbors, housing prices, reduced community engagement. It is about balance, but how do we measure and determine where that balance is. The Chamber of Commerce is projected to receive \$1.8M of 2023 budget funds to promote tourism on Tybee and the Hutchinson Island Trade Center is projected to receive \$900K funding from the \$6.4M projected revenue from the 7% hotel/motel/STR taxes. I understand these are approved by special option tax base. I do not believe that we want to limit or reduce tourism, that will impact the Tybee businesses; but if that is the desire, the city could reduce the tourism promotion. Then we need to look at how to compensate for the reduced income and realize the impact to businesses.

What is your approach to handling complicated and controversial issues?	Complicated issues can be broken down into smaller, detailed and more manageable topics. We can strive to understand the root cause and how we got to the position of having the issue. We need to be open minded to work with others for the best solution for our community. Engaging our community for input and listening to them as a whole, ensuring that we are hearing from more than a vocal few will help educate us. Researching and speaking to other communities on their solutions to issues similar to ours is reasonable.
Describe how you would work with city staff and your view of the ideal relationship between elected council members, mayor, and professional staff.	With a City Manager reporting to a Mayor and city council style government; the city staff reports to the city manager. The City Manager and staff provide for the cities daily operations with the guidance of the city ordinances. The city council represents the community citizens needs and wishes through long range planning accomplished with policy and ordinances. The city council may be involved with city staff in development of city ordinances, but is generally not expected to be involved in daily activities. I believe it is important for city council to understand the city staffs needs to support our city with the city managers acceptance of this communication.
What is your view about elected officials who change their mind when presented with facts that are new or that they did not previously know?	I very much appreciate elected officials who are open minded and make decisions from research, data, compassion and community input. I expect my elected officials to research and understand the issue as much as they are reasonably able to before the city council meeting, then listen to other council members and community input at the council meeting to make the best decisions that are good for our community.
What skills and experience do you have that you believe would be beneficial to our community if you are elected to serve?	 I am a flight test instrumentation engineer for the past 32 years. I have worked for 8 aerospace companies on 3 continents who are very good about defining detail processes and procedures, studying and understanding issues and working with others to provide the best and safest solution. I was on the board of directors of Alpha Phi Omega – National Service Fraternity through 2007 and 2008 focused on developing college age men and women as student leaders to provide community service. I believe my strengths of research, work ethic, positive attitude, willingness to listen to others, desire to share information with the residents and the desire for the well being of Tybee will help lead our community. NICK SEARS

Why are you running for Tybee City	For many years it has been my privilege to call Tybee my home and to enjoy
Council/Mayor?	the pleasure of Tybee life. The basic reason I am running for City Council is that in return I feel it is my responsibility to "give back" by making a meaningful contribution to Tybee and that I am best suited to do so by serving on the Council.
	In addition, during my lengthy involvement with the problems presented by the City's permitting short-term rentals in its residential districts I became increasingly disappointed in the Council's performance and decided that rather than simply complaining it would be more productive for me to try to improve matters by serving on the Council.
What do you believe is the role of City	The Council's main governmental functions are to legislate, provide
Council/Mayor in our community?	administrative oversight and to hire and fire the City Manager. The Council should assume a leadership role in the community by anticipating future issues and needs and by publicly setting out and then following guiding policies. In performing that role, the Council should take steps to keep its citizens informed of what actions it is taking or proposing to take, the status of those actions and the reasons for such actions.
What is your vision for Tybee Island? What	I hope that 10 years from now Tybee will "feel" pretty such the same as it
does Tybee "look and feel like" 10 years from now?	does today. It is my hope that 10 years from now the "look" of Tybee's public spaces and roads (particularly Butler Avenue) will be significantly improved by planting trees and increased landscaping. In addition over the next 10 years I see Tybee becoming an environmentally sensitive model for the Country no plastic bags or straws, no Styrofoam containers, significantly decreased use of gas powered vehicles, and continued focus on the health of our estuaries.
	I also envision Tybee in the future as a beach community that has come to grips with the fact that it has a very limited amount of space and that rational controls over the number of cars and people on the Island at any one time must be put in place.
Name one thing you want to do during your	My top priority would be the enactment of clearly written comprehensible
term if elected and describe why	legislation that would, over a period of time, reduce the number of STVR's
accomplishing this is your top priority.	permitted in Tybee's neighborhoods to well below the number allowed now and that would provide that STR permits shall not survive the sale of the houses to which they apply. That is, once a house is sold its STR permit will no longer apply to it but may be reissued in favor of another house so long as there are no more than the allowed number of permits outstanding.

How would you balance the benefits and impact of tourism and quality of life for residents?	Tourism is imbedded in Tybee's culture and is essential to its financial well- being. On the other hand, its neighborhoods are the soul of Tybee and must be protected by providing the residents with a quality of life that will insure the survival of the neighborhoods. Balancing tourism and the interests of residents should be to a large extent a matter of common sense. Tourism benefits from healthy neighborhoods populated by permanent residents who take part in its government and who voluntarily spend time caring for and maintaining Tybee; and tourism will suffer if it harms those neighborhoods by increased commercialization, traffic and overcrowding.
	For instance, restricting short term rentals in neighborhoods is necessary to protect their health and does no significant harm to tourism. Thus, in that instance common sense dictates that the neighborhoods' needs outweigh the wishes of the tourism industry. Of course, what constitutes common sense is not always obvious and can be a matter of opinion in which case
	balance can only be achieved by an enlightened Council.
What is your approach to handling complicated and controversial issues?	The first step in handling complicated issues or for that matter any issue is to create a clear statement of exactly what the issue is. The next step is to create an organized and correct statement of all pertinent facts (get the facts right). If the issue is controversial the next step should be to focus on the similarities rather than the differences between the various points of view. Finally, since it's almost never possible to please everyone a resolution of the differences must be found through compromise and good faith balancing of benefits against burdens.
Describe how you would work with city	A good deal of my answer to this question is found in Section 2.31 of Tybee's

"Except for the purpose of inquiries and investigations under section 2.15 of this charter the city council or its members shall deal with city officers and employees who are subject to the direction and supervision of the manager solely through the manager and neither the city council or its members shall give orders to any such officer or employee either publicly or privately." Further the Council, as a matter of practice, should appoint only one or two Members who may discuss any issue or area of concern with the manager and through whom other Members' questions or concerns about that issue should be communicated. Further direct communications between members and staff should only occur with manager's approval.
What is your view about elected officials	My view of an elected official who refuses to consider changing his or her

What do you believe is the role of City Council/Mayor in our community?	Tybee has a city manager form of government, so the role of city council/mayor is to set policy and to adopt ordinances that "protect and improve the public health, safety, and welfare of the citizens of Tybee Island". The mayor and council are also responsible for holding the city manager accountable, adopting a budget, setting tax rates, and focusing on strategic planning.
What is your vision for Tybee Island? What does Tybee "look and feel like" 10 years from now?	In ten years, I vision Tybee as the model of a small, vibrant island who successfully restored balance to the community. I see Tybee as a community who welcomes visitors, but not at the expense of our residents. I see a resilient community who celebrates and protects the natural beauty of the island.
Name one thing you want to do during your term if elected and describe why accomplishing this is your top priority.	Restoring accountability is my top priority. To start, the mayor and council must hold themselves accountable. Members of council must be prepared by reading the packet, doing their homework and showing up prepared, sober, and with an open mind. The second part of accountability is holding those who report directly to council accountable. This includes the city manager, the clerk of council, and the city attorneys. When we hold ourselves and others accountable, great things can be accomplished.
How would you balance the benefits and impact of tourism and quality of life for residents?	 For an island known for embracing visitors, the realization that we can't accommodate everyone at the same time on a 3 mile spit of sand has been difficult for many to accept. It's not a question of whether we need or want tourists, it's a question of how to manage tremendous numbers of guests/vehicles while ensuring public safety and the ability of visitors and residents to navigate the island without the frustrations of gridlocked traffic. To achieve balance on the island, we need to address the following: 1. Marketing - Although the state has interfered with our ability to do so, the city must have more input and control over how the island is marketed. The city has already taken steps to address how VisitTybee and the the island market Tybee, and as a result, ads now promote visitor etiquette. In my opinion, it just doesn't make sense to spend millions of dollars on promoting a crowded destination when the H/M tax money could be spent on improving the infrastructure, services, and attractions needed to support visitors. 2. Public Beach Issue - Tybee must work with county, state, and federal agencies to determine visitor capacity. It's not about restricting access or being elitist, territorial, or exclusionary; it's about protecting the essence of the island so that people will continue to want to live and visit here. Tybee must work with these agencies to develop procedures to deal with high volume weekends and to pursue alternative means of transportation to the island. 3. Remote Parking - Tybee usually has enough beach to support the level of visitors. What we lack is parking. I am very interested in pursuing remote parking locations and believe this will elevate much of the gridlock. 4. Preserving residential neighborhoods - I will work to prohibit additional STRs in residents in R-1, R-1-B, and R-2 neighborhoods.

What is your approach to handling complicated and controversial issues?	When faced with a complicated and/or controversial issue, I believe information and transparency are critical. When controversial issues come up, the public needs and wants Information. They need to know if/how the charter, the master plan, and the code factor into the issue. They want their opinions and concerns to be heard. I pledge to listen. At the end of this process, I will make my decisions based on the facts, relevant codes, and citizen input.
Describe how you would work with city staff and your view of the ideal relationship between elected council members, mayor, and professional staff.	Ideally, the mayor and council will establish a positive work culture based on trust and respect. If elected, I will work to foster a collaborative relationship between council and professional staff by being prepared, consistent, and willing to work as part of the team. I will strive to provide the staff with clear expectations and outcomes while refraining from meddling in day-to-day operations.
What is your view about elected officials who change their mind when presented with facts that are new or that they did not previously know?	I find the ability to view new information objectively and then reconsider previously held perspectives to be a very positive characteristic. It has been my experience that elected officials with this trait are highly effective, successful leaders.
What skills and experience do you have that you believe would be beneficial to our community if you are elected to serve?	I have four years of experience serving on city council and have held leadership positions in several organizations including the Tybee Island Marine Science Center, the Humane Society of Greater Savannah, the Savannah Skate Park Committee, Tybee Beautification, Forever Tybee, and the Lutheran Church of the Redeemer. In these positions, I was/am known for scrutinizing budgets and instituting evaluation processes while creating new programs and consistently demonstrating the ability to organize and execute. BILL GARBETT

Why are you running for Tybee City Council/Mayor?	I am running for council because I believe I represent those on Tybee who value an honest, efficient, cost effective, fair and representative city government focused on residents. I believe I have demonstrated that I will listen to all sides of an issue before making a decision and I pledge to continue to do so. I believe I have made and will continue to make a positive impact on the way Tybee is run.
What do you believe is the role of City Council/Mayor in our community?	The key role of the City Council is to decide which ordinances are necessary to ensure the welfare of our community. Surprisingly, all of these can be controversial and require careful consideration and discussion.
	One additional note. Council members do not direct the day to day operations of the city. That is the job of the city manager who reports to the council.

If I were transported to a future Tybee in 2033 I would hope that I would still be able to recognize it. I would hope that the houses were occupied by full time residents. I would hope that we don't have skyscrapers along the beach.
Name one thing you want to do during your term if elected and describe why	I've been accused of longing for Mayberry, but I say that's not a bad thing. My mission is to prevent the further intrusion of STRs (Short Term Rentals) into residential areas.
accomplishing this is your top priority.	There are problems associated with the high percentage of transient, non-owner occupancy such as noise and lack of on-site supervision. The bigger threat, however, is the loss of the community which defines us. We need to ensure that long term residents do not become the minority.
	Long term residents volunteer for and support the innumerable community programs which unite us, the Post Theater, American Legion, Shrine Club, TIMA, the Y and all its youth sports and classes, Tybee Arts Association, the Pantry, Pirates Fest, the St. Patrick's parade. Who would want to open a dental practice, a vet office or a car repair shop where the clientele is dependent on a declining residential client base? In a landscape of merely beach homes for tourists we would end up pretty much with only restaurants, gift shops and bars. In a future where STRs outnumber owner-occupied homes, who is going to form the community base to support the programs that make Tybee a joy?
	What is my plan? First, we must protect the current ordinance. There are current council members and council candidates who favor repealing it. If repealed it would open the floodgates and drown us in a sea of mini-Holiday Inns and eventually overwhelm our residential communities with STRs. Second, we must pursue options to accelerate the return of STRs to homes through attrition. Currently, an STR license continues with the land, owner after owner, until the owner stops operating an STR. This needs to be changed so that the license expires with the transfer of the property to a new owner. Short term rentals should never have been allowed in residential neighborhoods. A review of the descriptions of the residential districts in Tybee's land development code describes residential land uses as, "Quiet, livable, low-density single-family

	neighborhoods," "The character of development in these areas is oriented for permanent residents." and "Commercial and industrial uses are incompatible." Frankly, this was Tybee in the mid 90's when we settled here, and it remained so for about 20 years. When the influx of STRs began, it seemed innocuous, but then we began to see STRs overwhelm neighborhoods. Now, in our residential neighborhoods, every third residence is a registered STR with over 700 registered STRs. Enough is enough. There are about 1,200 housing units in our commercially zoned districts and about 2/3 of these are registered STRs. This is where our transient housing belongs.
How would you balance the benefits and impact of tourism and quality of life for residents?	Tybee is a tourist destination. Balancing the benefits and impact of tourism with the quality of life for residents is tough. I feel like the current "balance" is tourists get 6 months then residents get 6 months. Sometimes it feels like residents get the short end of the stick, but that's not always true, residents get to enjoy the island year round. There is no simple solution here. We reap substantial economic benefits from our visitors and our visitors often overwhelm the island. I don't have silver bullet here. We need to vigorously enforce our codes and we must continue to collaborate among residents and businesses to seek that "balance".
What is your approach to handling complicated and controversial issues?	"For every complex problem there is an answer that is clear, simple and wrong." H. L. Mencken Solving complicated, controversial issues requires fact finding, open communication and cooperation. It is important that we understand all applicable laws as the city may be constrained as to what it can do. Problem solving requires a commitment by all parties to finding a solution which is fair and benefits Tybee's residents first of all.
Describe how you would work with city staff and your view of the ideal relationship between elected council members, mayor, and professional staff.	The ideal relationship between council members and professional staff would be that of colleagues looking for what is best for the city and its residents. I have utmost respect for the city staff. I have always found them to be a reliable source of information as to the operation of the city. I will continue to do so.
What is your view about elected officials who change their mind when presented with facts that are new or that they did not previously know?	Smart. As Justice Felix Frankfurter stated, "Wisdom too often never comes, and so one ought not to reject it merely because it comes late."
What skills and experience do you have that you believe would be beneficial to our community if you are elected to serve?	Tybee resident since 1995 My wonderful wife Chris and I married in the jungles of Guatemala 52 years ago. We have two sons who both live in Atlanta. For over 30 years I worked as a research forester in forest productivity at the University of Florida, Union Camp and International Paper. I know how to analyze information. I have been active in the Tybee community, serving on Planning Commission for 2 years, City Council for 8 years, as well as participating in Better Hometown/Downtown Development Authority, Tybee Island Historical Society, Tybee Marine Science Center, Tybee Beautification Association and other groups over the years. Council members should be available for our residents concerns.
