## 2020 REGULAR SEASONAL AGREEMENT

**CHANGE OF LOT** Seasonal may, at his/her option, change lots at any time, subject to availability.

**EXTRA CHARGES** Any other charges, such as pump outs or any municipal, provincial or federal levies, taxes or assessment shall be payable upon request or invoice.

Upon such termination, Seasonal shall be paid a refund calculated as follows: - by deducting 10% of the full Season Fee for each week or part of occupancy from the 1s of May until the full Fee is depleted. <u>THEREAFTER, THERE</u> <u>WILL BE NO REFUND.</u>

<u>ASSIGNMENT AND USE</u> This agreement is not assignable to any other party. Principal use of the lot shall be by Seasonal or member of his/her immediate family. Use by any others shall be subjected to the regular rules and charges as may be in force from time to time during the term of this Agreement.

<u>PAYMENT</u> The Payment of a \*deposit and winter storage fee \$508.5 (\$450 + HST) and signed copy of this agreement are required by **February 28, 2020.** 

The balance of \$1,468.15 (\$1,299.25 + HST) must be paid on/or before May 1st, 2020.

\* The deposit / Winter storage fee will not be refund, in case camper withdraws from this contract after March 15<sup>th</sup>, 2020.
