There is very little interruption of one's family and existing social supports. There are group therapy sessions and a family education session each week.

The program focuses on all forms of adult chemical dependency, including:

Alcohol Cocaine Marijuana Opiates Prescription drugs

The adult program is offered in the morning at 9:30 am - 12:30 pm. Regular Alcoholic Anonymous and/or Narcotics Anonymous meetings during the week add to this program's effectiveness.

In addition to the completed application, we also require results from a TB test from within the last 90 days, a physical exam from within the last six (6) months, as well as records from any previous treatment providers. Amethyst staff can send for the treatment records, provided you complete and return a Release of Information (ROI) form for your treatment provider. Once we have all of the required documentation, we will contact you by phone or in writing to schedule an interview with our staff.

The men's and women's houses are priced the same at a monthly flat fee of \$500. Discounts are available for those that enroll in the Recovery Works Program. - Residential costs include room and board (i.e. rent, utilities, food) as well as weekly case management sessions. Please note that this does not include the costs of required outpatient treatment.

**Homeless Shelter:** Our men's shelter opens every day at 4:00 PM. The shelter provides two meals a day and a bed for all that request it. We handle all except for those with behavior concerns. Men leave the shelter each day at 7:00 AM and may return that afternoon.

**Recovery Program:** Clients live at the Hope House as long as their individualized program lasts, usually about 4-6 months.

**Mentoring Program:** Upon graduation, men may be eligible to stay at the Hope House and work as mentors. They live in the building and earn income to help get a new start.

**Halfway House:** Rather than working as a mentor, some men elect to continue living at the Hope House but to work in the community. The Halfway House program allows them to ease into society in a new community setting.

### **Men's services:**

**Emergency Services** - The Mission provides temporary emergency shelter to homeless and/or disadvantaged men. Breakfast, lunch, dinner, showers, clothing, chapel services, case management (with referrals to onsite and offsite social service agencies) are provided. Medical, dental, podiatric and vision services are also available.

**Working Guest Program** - This program is for homeless men who have secured employment and need additional time to reestablish themselves in the community. Residents are evaluated at the end of 30 days to determine their status. A man may be extended an additional 30 days based upon his finances and progress in the program. These approved extensions may add up to a maximum of six months. All program men are required to save a minimum of 65% of their income and must participate in biblically-based life skills classes and electives. Provisions are also made for homeless men who are working night shifts.

**Residential Programs** - Our men's residential programs provide shelter, meals, and case management for men in non-addiction programs. The goal is to help them obtain long-term, lasting change in their lives through a relationship with Christ.

**ACTS (Advocacy, Community and Transitional Services) Program** - The ACTS Program is a three-month program designed for men who have graduated from either the STEPS Program or Wheeler Mission's Addiction Recovery Program for Men. Graduates continue to receive shelter and food while in the ACTS program. The primary purpose of ACTS is to assist the graduates in three primary areas: church involvement, employment, and housing. This program helps the graduates by growing their network and becoming involved members of the local church and community. The ACTS Program acts as a liaison between program graduates and society.

**Addiction Recovery** - Our Addiction Recovery program for men is a long-term, residential opportunity to receive help with addictions and other life-dominating sin. This program begins at either our **Indianapolis or Bloomington, Indiana locations** with our Orientation Program.

**Addiction Recovery Orientation Program for Men** - Our Addiction Recovery Orientation Program for Men begins with our Orientation Program. During this 4-6-week program, assessments are completed to gauge readiness for change. Legal, medical and other needs are assessed for stabilization. During this time, men will learn to work, relate to others in the program, and attend biblical teaching classes. After this 4-6-week Orientation Program, men may enter the 6-month Addiction Recovery and Discipleship Training Program at our Training Center at Camp Hunt.

**Addiction Recovery and Discipleship Training Program** - This is a long-term, residential opportunity for men to receive help with addictions and other life-dominating sin. This six-month training program is designed to help men learn how to biblically overcome addictions and life-dominating sin. Men will be a part of a group where they will study through the Self-Confrontation: A Manual for In-Depth Biblical Discipleship together with support and training from their assigned Program Manager. During this time, they will attend classes with seminary-trained instructors and engage in work training with our various work crews at Wheeler Mission Pallets & Industry for a work reference after successful completion of the program. Men will also have the opportunity to fellowship with members of local churches for weekly Bible Studies. They will learn what it means to take ownership of their actions, engage in seeking forgiveness, and address their own forgiveness issues. The goal is not just to see men use this training for themselves, but to also see them use this training to learn how to help others. After 22 weeks, men may complete an optional exam and earn their Training Certificate in Basic Theology and Biblical Counseling. This would make other ministry training opportunities through Wheeler Mission available to them. After completion of this program, graduates may return home, join our three month Advocacy, Community, and Transitional Services program, or enroll in our Servant Leadership Training Program.

**Family Counseling and Advocacy Service** - For men at our Training Center who are married and/or have children, we offer our Family Counseling and Advocacy Service. The goal of this service is to allow each man to grow, heal, and be equipped with discipleship training alongside his wife and/or children. We believe that families need to heal together, not apart. We offer weekend housing and biblical counseling for men enrolled in this service.

**Servant Leadership Training Program** - Men who have received their Training Certificate in Basic Theology and Biblical Counseling may apply to enter the nine-month Servant Leadership Training Program. This advanced course of ministry training offers men an intensive look at serving others as a way of leadership while engaging in four college level Systematic Theology courses and two practical application courses in Biblical Counseling and Servant Leadership. They will be mentored by a Program Manager while continuing to address their personal life issues. Men will assist program management staff with leading other men in the Addiction Recovery and Discipleship Training program while developing their own gifts and talents. They will also be given training to prepare them for Biblical Counseling Certification with the Association of Certified Biblical Counselors. The Servant Leadership Training program may be taken at either the Training Center, Indianapolis, or Bloomington campuses. Upon successful completion of the Servant Leadership Training program, men will have earned their Training Certificate in Advanced Theology and Biblical Counseling. This certificate allows them to receive potential college scholarships and college credits with our University collaborations, along with other ministry training opportunities.

### **Homeless Women and Women with Children**

**Emergency Services** - Our Emergency Shelter Services for women and women with children is a 30-day program designed to assist women with basic temporal needs, like meals and shelter, while assessing the factors that led them to homelessness. Whether addiction, mental health, medical, occupational, or educational issues, ladies are encouraged to enter our other long-term programs that can help them with recovery, securing safe housing and employment or mental health care.

**Residential Programs** - Our women's residential programs are designed to address the specific issues that contribute to life instability and, in turn, homelessness. The primary goal of these long-term programs is to walk alongside women and children as they either enter or strengthen their walk with Christ.

**Fresh Start (Working Guest) Program** - Our Fresh Start (Working Guest) Program is a 6-month residential program designed to assist women to become independent through job training, job procurement, and stabilization. Guests receive individualized case management, educational training in our computer lab, work therapy, career development and life-skill classes, spiritual training and counseling. The goal is to have the clients move to safe affordable housing within 6 months, find employment, mend broken relationships, demonstrate life change and be involved in a follow up program for up to one year.

**Connect to Care Program** - Our Connect to Care (C2C) program is designed to address those ladies who come seeking shelter and have additional issues that require connection with an outside provider to promote a successful move to future stability. The C2C program allows those women to connect with local providers and their services while having the stability of housing with Wheeler Mission. Often this connection is made with mental health providers who also offer housing opportunities and an extended stay at Wheeler Mission is essential for that process to come to completion. While in C2C, the women are able to undergo counseling, medical care, and medication stabilization with their service team while

the Center staff provides added support through the day-to-day challenges that are often intensified with a chronic illness or mental health diagnosis. The ladies in this program work a scheduled day attending life skills classes (Anger Management, Life Skills, Addiction/Recovery, Communication Skills, Financial Management, Healthy Relationships, etc.), as well as weekly Bible studies. They also spend time in the Education Center improving academic and or employment skills, working in our Job Center, attending educational/employment training, job seeking, or working assignments around the building. The stay for this program is typically 6-9 months, although there is flexibility for an extended stay if the woman continues to be in compliance with the direction of her mental health provider and the Center and is working to make the final steps in securing safe and affordable housing.

**Family Development Program** - Our Family Development Program for mothers and their children is a residential program lasting 6-9 months. It is designed to provide stabilization, spiritual development, and skill development. Classes in parenting, life-skills and career development are included. An individualized educational program is supplied for the mothers where they can prepare to earn their GED or improve basic skills. Individual case management and counseling are an important part of this program. Assistance is given with regard to housing and employment procurement.

As a part of the Family Development Program in Indianapolis, we offer a state registered child care ministry with a strong educational emphasis. When mothers are in classes, the children attend age-appropriate educational programs, which include preschool education preparation, social behavior lessons, physical exercise and motor skill development, craft time and introduction to Biblical themes through fun story times. Positive mother and child interaction is facilitated and encouraged.

### **Addiction Recovery**

**Higher Ground Addiction Recovery Program** - The Higher Ground Addiction Recovery Program is a transitional, residential program for women struggling with substance abuse issues. It begins highly structured and freedoms increase as the program continues, through a minimum of eight total months. The program is designed to focus on total life change, rather than a single focus on the addiction. The foundation for this change is a relationship with Jesus Christ. The goal is transformation with minds focused on a desire to please God rather than self. Curriculum includes recovery classes and group and individual counseling. Life skills classes are offered in anger management, financial management, and healthy relationships. Ladies also have Bible studies and learn how to apply the Word of God to daily decision making. The progressive nature of the programming allows for growth in skills to include meal planning, shopping, budgeting, and other independent living responsibilities. Individual mental health counseling is available both in-house and with coordinating agencies. The program offers many avenues for developing healthy relationships that will be longstanding upon completion of the in-house programming, so that each graduate leaves with a secure support system in place. Throughout the Higher Ground program, guests participate in Wheeler Mission's cottage industry called Restored Creations.

**Connections Program** - Following the eight-month Higher Ground program, a graduate may choose to enter our Connections Program, which offers the graduate continued support while she continues reside under the security of Wheeler Mission's Center for Women & Children. During this program, the participant would be expected to secure employment and maintain savings in an effort to obtain safe and affordable housing or participate in an educational training program.

**Servant Leadership Training Program** - Also available following completion of the program is the opportunity to participate in Servant Leadership Training (SLT). This person will serve as an intern in the ministry for another nine months following completion of the Higher Ground program. This program is designed for those who desire an extra challenge and have a desire to further their relationship with God through service in a ministry. These participants will have opportunity to attend biblical counseling classes as well.

- some exceptions are made. in order to qualify for adult detox again... they must be in extreme state of withdrawal such as seizure, drug induced psychosis, danger to themselves or others. they stressed in withdrawal and stated if they just used before walking in the door they will not accept them.
