 On October 29, 2020, at approximately 6:08 PM I attempted to stop a green Honda CRV for failing to display a front license plate on W 6th St near Ash St in The Dalles. The vehicle was operated by a white male and there was a female riding in the passenger seat. The driver eluded southbound on Ash Street from W 6th St. I did not pursue the vehicle. The vehicle was last observed heading south on Myrtle St from W 7th St. I checked the area and did not find the vehicle abandoned. At approximately 6:45 PM The Dalles Police Department was dispatched a report of the suspect vehicle abandoned in the alley behind Center Market off Walnut St and W 9th St. The vehicle was determined to be stolen and was recovered from the scene.

 *** E CRASH ONLY *** On October 30, 2020, at approximately 12:18 AM the Oregon State Police and Gilliam County Sheriff's Office responded to a single vehicle crash at MP 115 I-84 EB in Gilliam County. The investigation determined the driver, Jordan Gibbs, was driving a gray 2018 Kia Optima sedan eastbound in the B lane when a deer crossed the road in front of him. Mr. Gibbs was unable to avoid the deer and struck it causing extensive damage to the grill and hood of his vehicle. No other vehicles were involved. Mr. Gibbs was evaluated at the scene by medics for minor cuts due to the crash. The vehicle was towed from the scene by Arlington Towing.
