## ABOUT THE FILM

Contending with the constant attack on Immigrants and Immigration Law, the lawyers on the frontlines are feeling burned out and disillusioned. 'Status Pending' takes us into the lives and work of five members of an informal support group comprised of Mexican-American, solo-practitioners who got their start at the same high-intensity law firm in Los Angeles. Through their friendship and constant communication, the five lawyers provide professional and emotional support for each other as they navigate the constant attacks on their clients and profession. 'Status Pending' won the 2019 IF/Then Shorts Pitch competition for the American West and was supported by Tribeca Film Institute and the National Association of Latino Independent Producers (NALIP). 'Status Pending' is distributed by Collective Eye Films and was broadcast internationally as part of Al Jazeera English's flagship documentary strand, WITNESS, as well as NBC's Meet the Press.




## ABOUT THE LAWYERS

#### PRISCILLA GONZALEZ SAINZ

Priscilla Gonzalez Sainz is a Mexican-American documentary filmmaker and writer based in Southern California. She is interested in exploring themes of displacement, identity, and transnationalism that call social and political barriers into question. Priscilla earned her MFA in Documentary Film and Video from Stanford University, where she was awarded a Stanford Arts grant and curated the Latin American Cinema series Espejos. Her thesis film ROOM 140 portrayed accounts from asylum seeking immigrants on the night they were released from detention centers. The film was a Student Academy Award Semifinalist and was nominated for the IDA Wolper Student Documentary Achievement Award. In 2020, Priscilla completed STATUS PENDING, a 26-minute documentary featuring five Mexican-American Immigration Lawyers who created an informal support group to help their clients and each other navigate the hostile world of immigration law under the Trump administration. STATUS PENDING won the IF/Then Shorts Pitch for the American West, receiving funding and distribution mentorship. The film was supported by Tribeca Film Institute and NALIP. Priscilla has contributed as a consultant and assistant editor on several award-winning films and teaches film production.
