The Fund, which will focus its investments primarily on US litigation and domestic commercial arbitration-related assets, welcomed several institutionally managed investors whose commitments to LF² exceeded initial expectations, and brought the Fund substantially closer to its USD \$100 million+ target.

LF² is co-founded by Michael German, a veteran litigator and litigation funder with more than a decade of experience investing in and resolving high-value, complex commercial litigation, and Chris Baildon, a financial services and investment banking expert with more than 30 years of experience across the industry.

“We are incredibly excited to officially announce our commercial launch and look forward to being disruptive to the litigation finance industry,” said Michael German, LF²’s Chief Investment Officer. “We have created an investment platform at LF² that permits us to quickly assess and make informed, data-driven decisions about the potential litigation investments we consider.
