Our program has zero involvement with wildlife on any farms or any control/hazing measures of any wildlife species, that program is DNR's depredation program which I've cc'd the supervisor to that program, Eric Nelson on this email.

Also in regards to HPAI surveillance of wild birds in our state, our WHP in DNR supports your USDA National Surveillance plan and sampling framework. We do not have a specified HPAI surveillance response plan at our state level. Our WHP responds to wild bird die-off events statewide, but this is for any disease that may be impacting that event, which avian influenza is typically on the panel of diseases to ruleout.
