After reviewing the meeting notes, here are the **action items captured**:

- National Pork Board action items (Lauren to help track)
 - (Lauren) *Schedule additional information session, specifically on consumer.
 - (Lauren) *Schedule meeting with CLEAR Center and Consortium to discuss Sustainability work that is underway.
 - (Lauren) *Schedule time with Jamie Burr and Ashley McDonald to go over research being done regarding Sustainability and research gap analysis. (Meeting is no longer needed as a report of research has been provided. Consortium will follow up with questions accordingly).
 - (Lauren) *Schedule time with Kara Behlke-Ungerman and Dr. Kristin Hicks-Roof to discuss Human Nutrition research.
 - (Lauren) *Schedule time with Kiersten and team to discuss retailer challenges related to Spectrum of Concerns.

 - (Lauren) Create an outline/visual of when items will be completed by to help demonstrate Consortium progress (include items outlined in the contract)
 - (Chelsey) Once 2024 Real Pork Scholars application timeline is defined, share with the Consortium.
- Consortium action items (Nick to help track)
 - (Communications Obj./Alexa Lamm) Creation of evaluation metrics and data collection process by the September Advisory Board meeting to be able to share with NPB for progress.
 - Think through how to incorporate Spanish translation of materials.
 - (Training Obj./Todd See) Think through different approaches on how to bring in individuals to do trainings to better leverage different channels such as Ted Talks, etc. This may open up possibilities to connect to consumers not previously accessed in the past.
 - (Nick) Please review the ROI metrics below and add specific dates to get incorporated in the outline/visual mentioned in NPB's action item list.
 - (Consortium) Reach out to University Communications contact to prep for announcement of Consortium.
 - (Consortium) Review the draft communications language on Real Pork Trust Consortium announcement once provided to group.

Return on Metrics measurements discussed: As a reminder, timeline for these items will run on an August-to-August calendar.

- Overall Effort for Year 1:
 - Contract set up by June 1
 - Subcontracts set up by July 1
 - Advisory Board members defined and first Advisory Board meeting held by September
 22
 - Announcement on Consortium at Leman Conference in September
 - 6-month progress report
 - Demonstrate how all work in the consortium ladders up to the Spectrum of Concerns.
- Communications Objective Year 1:
 - Set up Consortium website in collaboration with NPB Communications stakeholder and report out how porkcheckoff.org and the Consortium website fit together and deviate.
 - Content analysis is complete with an outline of information to populate on Consortium website.
 - Consortium Website populate with content outlined from content analysis.
 - Start social listening sessions with consumers.
- Research Objective Year 1:
 - Conduct gap analysis and outline the gaps as it relates to the Spectrum of Concerns to inform upcoming research within Consortium.
 - Approx. 12 15 graduate students hired on the Consortium.
- Training Objective
 - Launch 2023 Real Pork Training to connect the Real Pork Scholars 2023 Cohort grounded in Spectrum of Concerns.
 - Workshops on translating scientific pieces on the website (POSSIBILITY more discussion within Consortium on what this looks like).
 - Outline of Year 2 training.

Next Steps:

- (IN PROGRESS) Jerry / Lauren to work with Nick on getting contract and purchase order in place for the work to formally start.
- (IN PROGRESS) Becky and Alexa to work through draft communications on Consortium Announcement (due by June 1).
- Becky and Alex to work through Consortium logo and branding (due by September)
- Hold NPB Stakeholder meetings outlined above with Consortium members.

As we progress forward with the contract, I will keep the group updated on the status of the action items and next steps outlined above for awareness.
