ESSER Funds Explained



Esser I Cares Act

"The Department awarded these grants to State educational agencies (SEAs) for the purpose of providing local educational agencies (LEAs), including charter schools that are LEAs, with emergency relief funds to address the impact that COVID-19 has had, and continues to have, on elementary and secondary schools across the Nation."

Esser II CRSSA Act

"The Coronavirus Response and Relief Supplemental Appropriations (CRRSA) Act, 2021, was signed into law on December 27, 2020, and provided an additional \$54.3 billion for the Elementary and Secondary School Emergency Relief (ESSER II) Fund."

Esser III ARP Act

"On Thursday, March 11, 2021, the American Rescue Plan (ARP) Act was signed into law. It was an unprecedented \$1.9 trillion package of assistance measures, including \$122 billion for the ARP Elementary and Secondary School Emergency Relief (ARP ESSER) Fund. Funds are provided to SEAs and LEAs to help safely reopen and sustain the same operation of schools and address the impact of the coronavirus pandemic on the Nation's students."






Percent of Budget Spent on Learning Loss (District)




Percent of Budget Spent on Learning Loss (Charter)




Percent of Budget Spent on Educational Technology




Percent of Budget Spent on Educational Technology (Charter)




Percent of Budget Spent on Mental Health (District)




Percent of Budget Spent on Mental Health (Charter)
