
PLEASE HELP SECURE THE FUTURE OF THE AUSTRALIANA FUND AND ITS COLLECTION FOR THE NATION



Carved with the crest of Thomas Daniel Chapman, Premier of Tasmania 1861–1863. The Australiana Fund is an independent membership organisation established in 1978 to raise funds to collect and preserve works of art reflecting Australian culture, history and contemporary creativity for display and use in the nation's four Official Residences.

The Fund acknowledges the foresight of its founder, Tamara Fraser AO who was inspired by Jacqueline Kennedy's initiative in 1961 to establish The White House Historical Association to acquire artworks and décor for the White House.

We are thankful to the many people, notably our Members and Supporters, whose fundraising and generous donations enables the acquisition of The Fund's significant working Collection on show in Government House and The Lodge, Canberra, and Admiralty House and Kirribilli House, Sydney.

Furniture for daily use is at the core of The Fund's Collection. These hall chairs are in the State Entrance main hallway in Government House, Canberra. The centre table is in the State Drawing Room and is used by the Governor-General when conducting investitures and for the commissioning of the Prime Minister and Cabinet Ministers.

The Official Residences are the settings for Australia's Governor-General and Prime Minister to receive royal guests, heads of state, international dignitaries and Australia's citizens. Here our leaders fulfil their constitutional, ceremonial and public duties – the perfect locations to present Australia's fine and decorative arts, and design – our shared history and contemporary creativity. In a typical year, the Governor-General officiates at more than 560 official engagements, and welcomes over 8,700 guests, visitors and school groups to Government House and Admiralty House.

On Open Days, The Fund's Collection is seen by thousands of people and Fund volunteers talk with visitors about the histories of the Residences and their occupants, as well as The Fund's Collection. The Fund cares for and conserves the Collection to ensure that the artworks and furniture, on display and in use, enhance the Residences' high standards of presentation.

The Yarralumla cabinet, designed and made by Australian master cabinetmaker, Geoffrey Hannah OAM, is being conserved as part of The Fund's continuing Collection Care program. School groups love seeing Government House staff 'open' the cabinet doors and demonstrate the secret drawers. Made with over twenty-two Australian and exotic timbers, the cabinet has inlaid panels depicting Australian flora and fauna.

With loans of artworks to museums and galleries for exhibitions, the Collection is seen by a wide audience. The Fund's book, Collecting for the Nation - The Australiana Fund (2017), paid for by donations, tells stories of Australia, the Official Houses and their incumbents, through artworks in the Collection. So too does our program of national and state events, symposia, online lectures and, The Fund's website https://www.theaustralianafund. org.au/ and Newsletter.

Reaching a global audience, our Collection is online through the National Library of Australia's research database TROVE, www.trove.nla.gov.au as well as via eHive, a web-based system used internationally by hundreds of museums, societies, researchers and private collectors. www.ehive.com

OUR COLLECTION

The Collection's artworks are Australian by origin or by association and range from works by Indigenous artists and makers to contemporary design, sculpture, furniture, paintings, works on paper, presentation silverware, glass, textiles and ceramics.

The Collection tells many stories - from the long history of Indigenous peoples living in Australia, epic journeys of discovery and exploration, of migration and settlement to build a nation, to the coming of age of the Australia in 1901 when Federation united the nation. More contemporary are the stories about the maturing of a modern Australia taking our place on the world stage and seeking the best from our distinctive cultural diversity. Our goal is to strengthen our Collection by acquiring artworks representing priority themes in the Collection,

for example:

· Indigenous history and culture: historic and contemporary artworks representing artists and makers from across Australia. This spherical pot is by revered community elder, traditional owner and artist, Thancoupie

Sculpture by major Australian sculptors, especially for the Residences' gardens and landscapes. The Fund has several sculptures placed in the grounds and interiors of Government House and The Lodge, including work by Clement Meadmore and Inge King AM. Robert Klippel's sculpture is on display in the Chancery

Contemporary Australian crafts and design, including commissions of furniture and objects to meet specific needs of the Residences. An example is the pair of table bells commissioned from silversmith and designer



- Artworks and objects related to heads of state and prime ministers, and significant figures, movements and events in Australia's political, industrial, social, artistic and cultural development. This bust is of Edmund Barton, Australia's first Prime Minister, who was sworn into office at Centennial Park, Sydney on January 1st 1901.
- The powerful influence of migration and settlement in shaping Australia with its distinctive cultural diversity. The painting 'The parting cheer' by Henry Nelson O'Neil, captures the drama of the moment of separation when immigrants left British shores to make the voyage to Australia. Successive waves of migration from diverse countries continue to contribute to Australia's culture.
- Works by women artists and makers are a priority, especially contemporary crafts, design and artworks across a range of media.
- Australia's flora, fauna and landscapes represented in a range of artworks depicting species and scenes from across Australia. In the 19th century, colonial silversmiths decorated emu eggs with Australian flora and fauna motifs for the growing market of souvenirs and trophies.
- Artworks on paper depicting collection themes to enable the rotation of artworks on display for conservation best practice. A map drawn in 1753 by French cartographer Jacques Bellin of Australia's charted and uncharted coastline is on display in Admiralty House.

STRATEGY

Our strategic plan provides a clear direction for the future:

- A significant collection presenting to the nation stories of culture, place, identity and memory which inspire Australians to celebrate and cherish their distinctive cultural heritage and contemporary creativity.
- A recognised and respected organisation well supported by Members, supporters and donors, operating in a financially sustainable way, and preserving and maintaining its significant collection.

The Fund relies on the voluntary commitment of its Council and Members to fulfil its unique role of collecting for the nation to contribute to the high standards of presentation in Australia's Official Residences. The Council is led by the Chair who is elected from the ten Council members, who are themselves nominated for election by the State Committees.

The Fund employs the Fine Arts Advisor (a permanent, part time position), and a casual, part-time assistant. The Fine Arts Advisor is responsible for the management of the Collection, liaison with the Official Residences, with the Chair and Council and, The Fund's relationship with its Membership.

The State Committees are key drivers of fundraising to support The Fund's activities, especially acquisitions, but also specific projects such as Collection care and conservation projects, publications and symposia.

FINANCES

The Fund is recognized by the Commonwealth Government's Cultural Gifts program and is a registered, not-for-profit charity under the requirements of the Australian Charities and Not–for-Profits Commission (ACNC).

All acquisitions for the Collection, and its conservation and care, are financed through donations, grants or sponsorships. The Fund's operating costs are met through membership fees and a yearly Grant in Aid from the Government. The Fund works closely with the Office of the Official Secretary to the Governor-General and the Department of Prime Minister & Cabinet through a tripartite Memorandum of Understanding (MOU) to ensure mutual goals and expectations are managed and achieved.


A SUSTAINABLE FUTURE FOR THE AUSTRALIANA FUND

To sustain The Fund in the long term, we must substantially increase our Endowment so that our annual income meets our annual operational expenditure and resourcing requirements. The Fund will continue to launch appeals for specific acquisitions and collection-related projects through targeted fundraising.

We recognise the challenges which our organisation faces in attracting community support when there are so many worthwhile charitable requests. Our target is to raise \$5 million over the next five years to secure The Fund's future by 2028 – The Australiana Fund's 50th Anniversary.

Your generosity will enable us to make priority acquisitions to ensure that the Collection reflects our nation's distinctive history, heritage and culture and to continue our program of conservation and care of the 'working' Collection on display and in use in the Official Residences.

We will also strengthen our engagement with a wider audience in the narratives of our nation represented in the Collection and the histories of the Official Residences.



SIGNIFICANT ACHIEVEMENTS

The publication of our book, *Collecting for the Nation – The Australiana Fund*, in 2017 has enabled new opportunities to promote The Fund. Our partnered program of online lectures and symposia with guest speakers from The White House Historical Association, USA (2017) and the Royal Collection Trust UK (2019) position The Fund in an international context. These sponsored events are fruitful exchanges of ideas, strategies and achievements and have led to increasing national and international interest in The Fund.

Our website, www.theaustralianafund.org.au, makes the Collection globally accessible as does our museumgrade collection database. Central to The Fund's success is our focus on the conservation and care of our 'working' collection – chairs are sat on, vases filled with flowers, silverware adorns the dining rooms and The Fund's magnificent Stuart and Sons piano is played. Our program of condition assessment, conservation treatment and care ensures that The Fund's Collection is both beautiful and practical.

Our Collection is the heart of The Fund and, since our establishment in 1978, many significant acquisitions have been made including these highlights.

This painting by Uta Uta Tjangala, a founder of Papunya Tula Artists Pty Ltd, was presented to The Australiana Fund by Papunya Tula Artists in 1981. The work represents the influential development of the 'dot and circle' paintings of the Western Desert Art movement

The sculpture, 'Up', by Clement Meadmore, one of Australia's most successful sculptors, was acquired to celebrate the Centenary of the Federation and to commemorate the New Millennium of 2000. Set in the grounds of Government House, Canberra, the dynamic work is framed by the landscape of the Brindabellas. The sculpture's acquisition was funded anonymously in 2000.

Commemorating the opening of the First Federal Parliament 9 May 1901, this medal is provenanced to HRH Princess Victoria Alexandra (1868-1935), who was present at this historic event.

In 2019, The Fund purchased the Munro Ferguson Collection, provenanced to Australia's sixth Governor-General, The Right Honourable Sir Ronald Craufurd Munro Ferguson GCMG PC, Governor-General of Australia (1914-1920). The collection includes 82 Australian timber samples carved to resemble books, each with the botanical and common name of the sample. Commissioned by Munro-Ferguson's friend, botanist Richard T Baker, both men were were foresters and ardent promoters of Australian timbers and their sustainable use in cabinetmaking and industry.

In 2021, The Fund commissioned the sculpture, 'Coming Together, Moving Forward, Standing Tall' for His Excellency General the Honourable David Hurley AC DSC (Retd), Governor-General of the

Government House to commemorate the Platinum Jubilee of Her Majesty Queen Elizabeth II. Depicting Australia's two iconic animals, the emu and the kangaroo from Australia's coat of arms, the sculpture was designed by Adam Humphreys who worked with BackTrack Youth Works, supervising the making of the sculpture. BackTrack teaches young people in regional NSW new skills and involves them in community life. Commonwealth of Australia and Mrs Hurley have been Patrons of BackTrack since 2016. This sculpture represents their involvement with diverse community groups. Given the ravages of bushfires, floods and the pandemic, support for communities across Australia has been a defining theme of Their Excellencies' term of office.
