These updates are procedural in nature and have no impact on operations. The revisions were made as part of a standard review after one year of use, to ensure alignment with actual practice. Changes to signatory model	<ul> <li>Board approval was sought for proposals from the Secretariat, endorsed by the Governance Committee, to make several changes to the current signatory model.</li> <li>Change of signatory fee levels for specific groups</li> <li>Include more accountability to signatories on activeness and acceptance of the CAF: Deploy accountability rules: 1. voting 2. annual signatory survey and 3. convergence (additional line in the Charter)</li> <li>Include academia and mission driven non-profits explicitly under caucus Civil Society (requires an update to the Bylaws)</li> <li>To obtain full Board approval, it was agreed that the Secretariat would seek signatory feedback via email communication (newsletter/newsflash) within a defined timeframe. No formal signatory vote is required.</li> <li>If no substantial objections are raised, SVB approval can be obtained via email.</li> </ul>	Outcomes - Changes approved by MB SVB approval paused pending signatory feedback

## **Decision Record**
