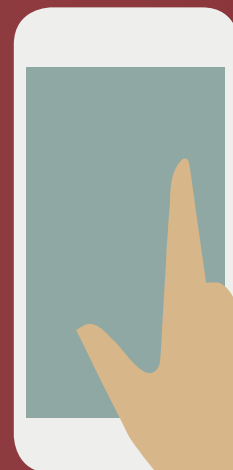

- 1** Status employees pay less premium because the coverage does not duplicate Non-Insured Health Benefits coverage
- 2** Fair disability income replacement for Status employees at 75 per cent non-taxable
- 3** \$400 vision care benefit every 24 months for adults, and 12 months for dependent children, plus one eye exam every 12 months for adults and dependent children
- 4** Enhanced Dependent Life Insurance to help cover final expenses, \$15,000 for spouse, \$7,500 for dependent children
- 5** Elders and Traditional Healers are recognized as treatment providers under the Employee and Family Assistance Program
- 6** Employees have access to coverage information, claims history and booklet
- 7** Claims are reimbursed into employee's bank accounts
- 8** Employees/Plan Administrators have access to on site visits, education sessions, and webinars. In addition, Plan Administrators have access to regional and annual workshops
- 9** Community Insurance providing Extended Health Care, Vision and Dental Insurance to all community members
- 10** Employees pay a rate that reflects the coverage they need, as the plan accommodates Status and Non-status family members/dependents, and can include grandchildren as dependents with no legal documentation
- 11** Prescription drug coverage for limited use/exception drugs, including assistance in ensuring proper coordination with Non-Insured Health Benefits
- 12** Employees can submit health and dental claims online
- 13** Employees have access to Non-Insured Health Benefits claim experts
- 14** A two-step dental claim process with Non-Insured Health Benefits
- 15** Three levels of Chief and Council coverage available including disability coverage for Chief and Council receiving honorariums
- 16** Special coverage options for part-time employees
- 17** High non-evidence maximums for life and disability insurance

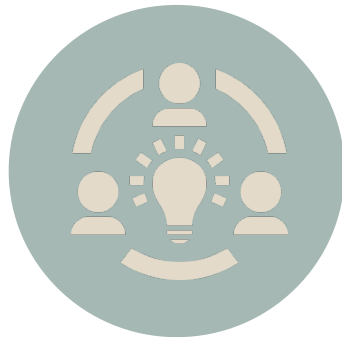
