

 Arlington Commission on Aging vision – "Arlington is a community where older persons thrive."


### Planning for an Aging Population



- ✓ Affordable assisted living


### Housing Affordability - Plan Objectives

- Identify options for home sharing
- Increase supply of missing middle units
- Advocate for policies that reduce financial burdens on older adults in need of housing
- Promote development of accessory dwelling units

#### Housing Affordability – Accessory Dwelling Units

- ADUs -- Smaller, independent second dwellings on single-family lot
- Have own living, bathroom & kitchen space
- Attached or detached
- Used for relative or friend, or rental for income
- 2019 County Board adopted new ADU standards

#### **Accessory Dwelling Units**








### Housing Accessibility – Plan Objectives

Promote universal design in new and rehabilitated housing

- Universal design safe, livable, usable for everyone regardless of age, physical ability, circumstance. Beyond ADA compliant.

#### Walkability in Arlington

- Walkability in several parts of the Age-Friendly Plan; bears on housing access
- Arlington already is highly walkable community; recognized as "Gold Walk Friendly Community"
- Monitoring of streets, walkways, open spaces to ensure safety & ease of use
- Examples eliminate brick pavers, ensure lighting & signage, "see me" street crossing flags

#### Age-Friendly Plan Goal – Affordable Assisted Living

 Objective – Require developers to set aside 5% of units in new assisted living facilities as auxiliary grant/affordable units

  - Review of Affordable Housing Master Plan
