Daniel and his team successfully installed the first handful of Trail Markers this week.



I'm writing today to report some disturbing incidents at Waterdog park.

I live here in Belmont and my backyard is directly adjacent to the open space. I hike and bike in the park multiple times per week.

A few weeks ago (November 20th) I was riding my bike clockwise around the lake trail and as I came down a steep hill into a corner I noticed Pat Cuviello holding his phone up as if to take photos or videos of me. He was standing right at the corner but slightly off the trail. As I came closer to the corner I saw Deniz Bolbol standing directly in the middle of the trail, right around the corner. I immediately recognized them as I've encountered them in the park in the past. As I slowed, almost to stop, Deniz just stood there silently in the middle of the trail, blocking the trail, with her phone out. I said something like, "Excuse me, I'd like to get by." She didn't respond, or move from blocking the trail, so I just sort of scooted to the side, off the trail a bit and went on my way.

It struck me as a very odd encounter, but as I continued to think about it, I realized they were intentionally placing themselves in a position where they could be hit by a cyclist, which would explain the strange behavior. At the very least it seemed like they might be trying to bait someone into getting angry and starting an altercation, or they might be just stirring up trouble with the intention of using the video recording later to justify their complaints about the other park users. At worst they might even be intending to cause an accident or injury with the purpose of suing a cyclist or the city.

I respect their right to express their views about park use, but at some point I think they have crossed a line where now they are just harassing other park users, and potentially endangering themselves and others.

Hello Belmont Parks and Rec Commissioners and Director,

My name is Marcelo Quiroz and I am a resident of Mountain View, CA and have lived in the Bay Area my entire life. Waterdog Lake Park is a special space and is where I first learned how to mountain bike back in 2005. I have grown up visiting Waterdog Lake Park and have been a regular visitor. The experiences, friends made, and memories are what make this space special, and I am sure other folks feel similarly. In my 15 years of visiting Waterdog Lake Park I have not had an unpleasant experience, despite the occasional poison oak rash.

It is my understanding that Belmont open space is not just for Belmont residents to access and enjoy.

From an August 5th City of belmont Commission Regular Meeting meeting,

"Belmont's asset is its open space, The goal here is to try and make Belmont's open space system safe and enjoyable for all visitors. That is, and should continue to be our goal"

Earlier this week I had an encounter with 2 Belmont Heights residents when exiting Waterdog Lake Park on my Mountain Bike. Both residents were waiting and engaged me in an aggressive way, yelling that I "was not supposed to ride here". Confused and alarmed, I proceeded to leave the area on bike, unaware that I was being followed in a vehicle by the 2 Belmont Heights residents. I arrived at my destination 4 miles away, with the both Belmont Heights residents arriving shortly after. They had followed me. I have learned that the 2 Belmont Heights residents are Pat Cuviello and Deniz BolBol (President of the Belmont Heights Civic Improvement Association). What followed was a concerning and unsafe verbal attack by Pat and Deniz that resulted in calling the police. Belmont PD is aware of this encounter and assured me that the behavior of Pat and Deniz was unacceptable.

This whole experience has shaken me and has me questioning if I am welcome at Waterdog Lake Park. I have learned that there is a vocal effort by residents of Belmont Heights to prohibit mountain bikers from Waterdog Lake Trail and that residents have engaged in similar encounters with other park visitors. I hope that in the future, Waterdog Lake Park can continue to be an inclusive and welcoming park where visitors can access and move about freely and safely without harassment from local residents.
