### **Agreement for Release of Liability**

In exchange for participation in Shamanic sessions, workshops, seminars and other events organized and conducted by or at the direction of Francine Parisi, and/or the use of facilities and services of Francine Parisi, I agree to the following:

1. AGREEMENT TO FOLLOW DIRECTIONS. I agree to observe and obey all posted rules and warnings, and to follow any oral or written instructions or directions given by Francine Parisi, or her employees, representatives, contractors or agents.
  
2. ASSUMPTION OF THE RISKS AND RELEASE. I recognize that there may be certain inherent risks associated with the above-described activity and I assume full responsibility for any and all injury to myself. I further release and discharge Francine Parisi from any injury, loss or damage arising out of my use of, presence in or involvement with the facilities and services of Francine Parisi, regardless of fault.
  
3. INDEMNIFICATION. I agree to indemnify and defend Francine Parisi against all claims, causes of action, damages, judgments, costs or expenses, including attorney's fees and other litigation costs, which in any way arise from my use of, presence in or involvement with the facilities and/or services of Francine Parisi, or her employees, representatives, contractors or agents.
  
4. FEES, CANCELLATIONS AND REFUNDS. I agree to pay Francine Parisi in accordance with the terms of the Registration and Authorization form attached hereto, and to follow the cancellation and refund policies described therein.
  
5. APPLICABLE LAW. Any legal or equitable claim that may arise from participation in the above shall be resolved in Maryland, under Maryland law.
  
6. NO DURESS. I agree and acknowledge that I am under no pressure or duress to sign this Agreement and that I have been given a reasonable opportunity to review it before signing. I further agree and acknowledge that I am free to have my own legal counsel review this Agreement if I so desire.
  
7. ARMS LENGTH AGREEMENT. This Agreement and each of its terms are the product of an arm's length negotiation between the Parties. In the event any ambiguity is found to exist in the interpretation of this Agreement, or any of its provisions, the Parties explicitly reject the application of any legal or equitable rule of interpretation which would lead to a construction either "for" or "against" a particular party based upon their status as the drafter of a specific term, language or provision giving rise to such ambiguity.

8. ENFORCEABILITY. The invalidity or unenforceability of any provision of this Agreement shall not affect the validity or enforceability of any other provision of this Agreement and such invalid or unenforceable provision shall be deemed not to be a part of this Agreement.

10. DISPUTE RESOLUTION. The parties will attempt to resolve any dispute arising out of or relating to this Agreement through friendly negotiations amongst the parties.
